Genealogists believe that early in the history of the United States, two brothers who were surnamed Coffey emigrated to this country from Ireland, and from those two men descends the large family of that name. After agreeing on these two points, however, genealogists have apparently "agreed to disagree," making the Coffey family, by far, the most difficult line researched for *Our Family's Book Of Books*.

The problem with the Coffey's has arisen from two major differences of opinion. First, the surname itself is spelled several different ways. Second, the facts concerning the life of Jesse Coffey are disputed by many of those who have studied the Coffey line.

The surname "Coffey" is often spelled "Cofey," "Coffee," "Coffe," or "Coffey." The last spelling is the one chosen for this project, because it is the one that appears most often in the research for this particular line.

Many genealogists believe that Jesse Coffey died unmarried. However, current information indicates that he did marry and, in fact, was the father of nine children, one of which was **Bashaba Coffey**, who married **William Jones**. (See Book I, Chapter I).

Many of the old wills and estate records, either failed to mention or deliberately omitted many of their own children. In some instances the children not mentioned were already deceased. This not only happened in the Coffey family, but every family researched in *Our Family's Book Of Books*.

Chapter 1

Edward Coffey

Edward Coffey came to America probably about 1690; settled in Essex County, Virginia; and died in Essex County before November 20, 1716. He married Ann _____.

Edward's will was recorded November 20, 1716, in Essex County, Virginia. The age of the will and the script in which it is written have made a full transcription nearly impossible. The following abstracts from that will and inventory have been included, however. These have been taken from ESSEX COUNTY, DEEDS AND WILLS 14, 1711-1716 (NEGATIVE PHOTOSTAT), pp. 669, 689-690.

"In the name of God aman I Edward Coffey being in bedd of Sickness".

Dated 14 February 1716. Probated 20 November 1716.

To two sons **John Coffey** and **Edward Coffey** all land to be divided equally, at 16 years if their mother is dead, otherwise at 18 years.

To daughter **Marther Coffey** a cow at 16 or her mother's death.

To son **John** a cow.

To wife **Ann Coffey** balance of personal property. At her death to be divided equally between "my six children **John Coffey** **Edward Coffey** **Marther Coffey** **Ann Coffey** **Anstor Coffey** **Elizabeth Coffey**."

Chapter 2

John Coffey

John Coffey, son of **Edward Coffey** and **Ann Coffey**, was born in Essex County, Virginia; moved to Albemarle County, Virginia; and was still living in 1774. He married **Jane Graves**, who was born in Spotsylvania County, Virginia, and died in Wilkes County, North Carolina, in 1792.

The following land transactions of **John Coffey** and **Jane Graves Coffey** are found in the Office of the Clerk of Court, Essex County, Virginia. The specific deed book, page number, and date of each record is noted at the end of each entry.

John Coffey and wife, **Jane Coffey**, of Spotsylvania County, Virginia, to **Silvanus Allen**, of Essex County, Virginia, in consideration of 25 pounds current money, a parcel of land lying and being in the County of Essex and Parish of St. Anne containing 100 acres, being part of a tract of 200 acres formerly called by the name of **Noseley's Quarter**, and bounded, viz: beginning at a corner oak and maple in a branch of **Gilson's run**, and running thence N-W 126 poles to a stake, a corner between the said land and the land of **William Ballard**, thence N-E 132 poles to a corner red oak sapling standing by the plantation of **Stephen Chenault**, thence along a newmade line S-E 126 poles to a hickory in the line of **John Garnett**, then along his line and the line of **William Taylor** S-W 132 poles to the beginning, together with all houses, woods, and under woods.

John Coffey died either in late 1774, or early 1775. He made his will on March 31, 1774, and one year later, in March of 1775, his executors were qualified in the Albemarle Court.

In the name of God Amen this Thirty first day of March and in the year of our Lord One Thousand Seven hundred and Seventy four, I **John Coffey** of Albemarle County & Parish of St. Annes in the Colony of Virginia, being some weak in body but of Perfect mind & Memory Thanks be given unto God, Therefore Calling unto mind the Mortality of my Body and knowing that it is appointed for all men once to die do make & Ordain this my last will & Testament That is to Say Principally & first of all I give & Recommend my Soul unto the hands of Almighty God that giveth & My Body I Recommend to the Earth to be buried in a Decent manner at ye the discretion of my Executors, nothing dothing that at the General Direction I shall Receive the Same by the Almighty power of God, and as Touching Such worldly Estate wherewith it hath pleased God to bless

me with in this life I give & Demise & Dispose of the Same in the following manner & to wit

Imprimis I order that my Just Debts & funeral Charges be first paid out of the whole

Item I give & Bequeath to my Sons **James Coffey & William Coffey** to Each of them five Shillings Sterling

Item I Lend to my Dearly beloved wife **Jean Coffey** during her widowhood the Rest of my Estate Real & Personal, and at the End of her widowhood to be Equally Divided among the Rest of my children Viz, **Thomas Coffey, John Coffey, Edmund Coffey, Reubin Coffey & Benjamin Coffey, Winifred Moran & Betty Field**, and the above Estate to be Sold at the Said Term of time

Item I Order **Thomas Coffey & Benjamin Coffey** as my Executors and I do hereby utterly disallow, Revoke and disannul all & Every other former will and Testament, Legacies & Bequeaths and Executors in any wise before named & Bequeaths, Ratify and Confirming this and no other to be my Last will and Testament, In Witness whereof I have heretanto Set my hand & Seal the Day & Year above written

The following document is a copy of the 1793 appraisement of **John Coffey's** estate, made about nineteen years after his death and apparently a few months after his wife's (**Jane's**) death. This appraisement was made in accordance with his last will and testament.

The Wife of The Said Deceased have by & with the Consent of the Legatees Hereafter Mentioned (To wit) **Thos. Coffey Benjn Coffey (Exec.) John Coffey Winefred Moran Edmund Coffey Reubin Coffey & Elizabeth Fields** have Authorized and Impowered the afore said Persons (To wit) **White, Boone & Gordon** To apraise the Estate of the Said Deceased agreeable to the Testament & Meaning of the Will of the Said **John Coffey** & the Said Appraisers have Proved & Authorised the Estate Presented to them and the aforesaid **White Boone & Gordon** Chosen by the Legatees have Said that the Estate is worth 1945:14. Exclusive of the Book Amounts & Likewise we **John Coffey Winefred Moran** by her Lawfull Husband **Nicholus Moran Edmund Coffey Thomas Coffey Reubin Coffey Benjamin Coffey & Elizabeth Field** by her Lawfull Husband **Thos. Fields** Do Jointly & Severally firmly by the above, Presents agree to Support Maintain & Defend The Proceedings agreed on by the Legatees above Mentioned Provided That any Suit or Lawsuit Should Commence against the Est. or Legatees so as to assist the Devision of the aforesaid Estate.

He married **Elizabeth Cleveland** of Bull Run, Prince William County, Virginia.

THE LAST WILL AND TESTAMENT OF JAMES COFFEY

In the name of God Amen

I **James Coffey** of Wilkes County and State of North Carolina being sick & Weak in Body; though of Sound and Disposing mind and Memory; and calling to mind that it is Ordained for all men to Die; Do make and Nominate This my last will and Testament Viz!

First I Recommend my Soul unto the hands of Almighty God that give it.

And my Body to be Buried in a Decent manner at the Direction of my Executors, And as to what worldly Goods that Pleased Almighty God to Bless me with I give and Depose of that in that in the following manner (To Wit)

It is my will and Desire that my Loving wife **Elizabeth Coffey** the whold of my Estate both Real & Personal (that shall Remain after paying my Just Debts and Funeral Expenses) during her natural life

Item I give and Bequeath to my Daughter **Betty Whiteside** my son **John Coffey**, my Son **James Coffey**, my Son **Reubin Coffey**, my Son **Alious Coffey**, my Son **Ely Coffey**, my Son **Rice Coffey**, my Daughter **Martha Durran**, my Son **Joel coffey**; my son **Levi Coffey**; And the heirs of my Son **Archelus Coffey**: The whole of my Estate Both Real and Personal of all kinds whatsoever: That shall Remain after my Just Debts and Funeral Expenses Shall be paid: to be Equally Divided among them at the Deceased of my Wife **Elizabeth Coffey** that is to say Allowing all the Heirs of my Deceased Son **Archelius Coffey** Jointly a part Equal to one of my Children and unto each of them an Equal Share with my Own Children;

Lastly I do Nominate and appoint my son **John Coffey** and my son **Reubin Coffey** Executors of this my Last Will and Testament, and do hereby Disannull all former Wills & Ratify and Confirm this to be my last will and Testament: In Witness whereof I have hereunto set my hand and Seal this Thirteenth Day of September in the year of our Lord one Thousand Seven Hundred and Eighty Six.....

The 1790 Burke County, North Carolina Census lists **James Coffey** as the head of the household, with one free white male under 16 years of age; three white females, including heads of families; and one slave. He obtained land in Wayne County, Kentucky, but he returned to North Carolina, exchanging his Wayne County land for his brother Lewis' North Carolina tract.
- III. **Reubin Coffey**, born Albemarle County, Virginia, September 16, 1759. According to land grants, **Reubin Coffey** was in Burke County, North Carolina, in 1778.
- IV. **Ambrose Coffey**. According to land grants, **Ambrose Coffey** was in Burke County, North Carolina, in 1778.
- V. **Eli Coffey**, born Albemarle County, Virginia, March 1, 1764; still living in 1859. The following entry is **Eli Coffey's** Revolutionary claim paper.

State of Tennessee
McMinn County

County Court May term 1839

On this 6th day of May 1839 personally appeared **Eli Coffey** a resident of McMinn County and State of Tennessee in open court before the Worshipful County Court for the County of McMinn aforesaid Upon setting, the same being a Court of record, aged Seventy five years, who being first duly sworn according to law doth on his Oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the Service of the United States under the following Named Officers And served as hereinafter Stated that he entered the Service of the United States as a Substitute in the room and place of one **Thomas Field** who was his Uncle by Marriage and who had a large family dependent upon his daily labor for subsistence. Said **Field** was drafted for three Months. Some time, as declarant believes, in the latter part of the winter or in the Spring of the year 1780 in the State of North Carolina, Wilkes County, at which time declarant entered the Service under Capt. **John Barton**, further during the time was occasionally under the Command of other Captains Namely, Capt. **Keyes**, **Moses Guess** & **John Beverly**, who was all commanded by **Col. Benjamin Cleveland** at that time also a citizen of Wilkes County N.C.

Declarant was engaged as a Scout after the Tories in the Counties of Wilkes and Burke.

During the time of his service he was Sometimes permitted to visit his Father. Some times was Scouted, from the enemy dis patched parties to be upon action duty when required and when danger threatened from the collection of the enemy.

In this Manner he served out his term of three Months and was regularly discharged.

He again entered the Service of the United States as a horse Man he thinks in the fall of the year 1781. He was a substitute for his Brother **Ambrose Coffey** who was drafted to go against the Cherokees and who was near sighted. He entered the Service as alter in Wilkes County in the State of North Carolina under Capt. **John Beverly** & Lieutenant **Isbell** of Wilkes, **Col. Miller** of Rutherford, **Col. Joseph McDowal** & **Genl Charles McDowal** of Burke, they rendezvoused at Pleasant Garden, Burke County N.C. crossed the Mountain at the head of Swannano. Marched down Swannano and crossed French Broad River the Big and little Pigeon River, and Tuckesegee at an Indian town called Tuckesegee, took the town, crossed the Tennessee River and head waters of the Hiwassee, passed through various parts of the Cherokee Nation and took and burnt down other Indian Towns towit, the over hill Towns, the Valley towns and the Shoosmake towns and then returned home and was regularly discharged at the expiration of the three Months, the term for which he had entered. These Services were all rendered before he was eighteen years old and at a time when he was not subject to Military duty and his discharge was obtained by his Father and he does not know what has become of them.

He was born in Albemarle County Virginia on the first day of March 1764. From Virginia he accompanied his Father to Wilkes County North Carolina, where he resided when the above Mentioned Services was performed. He went to Kentucky in the year 1784 and returned to Wilkes the Succeeding year whence he removed to Wayne County Kentucky and thence to

McMinn County, Tennessee where he now resides.

He states that he has a record of his age at his house. He was not acquainted with any of the regular officers of the Revolutionary war, never having served with any but was acquainted with all those heretofore named by him as his officers.

He states that he is acquainted with Robt Frazier, Henry Bradford and Nealy Chrisman in his present neighbourhood, who can testify as to his character for viracity and their belief of his services as a Soldier of the Revolution.

He further states that he has no documentary evidence of his Services and knows of no person by whom he can prove the same except **Martin Durham** a citizen of Wayne County Kentucky whose statement is here with submitted.

He hereby relinquishes every claim whatever to a pension or Annuity except the present and declared that his name is not on the Pension Roll of the agency of any state.

He Robert Frazier a clergyman residing in the County of McMinn and State of Tennessee and Henry Bradford and Nealy Chrisman residing in the same County and State hereby certify that we are well acquainted with **Eli Coffey** who has subscribed and sworn to the above declaration, that we believe him to be Seventy five years of age, that he is respected and believed in the neighbourhood where he resides to have been a soldier of the revolution and that we concur in that opinion.

Eli Coffey's name appears many times in the Minutes of the Yadkin Church. At the monthly meeting in July, 1790, **Thomas Coffey**, **Eli Coffey** and **Martin Durham** were appointed to repair some mistakes in the church book. At the monthly meeting in April, 1791, the church appointed **James Coffey**, **Eli Coffey**, and **Jonathan Boone** as delegates to the Association and ordered the clerk to prepare a letter for the church. At the monthly meeting in January, 1792, the church appointed **Thomas Coffee**, **Jesse Boone**, **Eli Coffey** and **James Coffey** to meet with **Moses Hull** and **William Lansdowne** to endeavor to know the difficulty that was between them. At the meeting held on the Second Saturday in January, 1800 the following delegates were appointed to Globe church to look into the standing of members causing grief - **Thomas Coffey**, **Jonathan Boone**, **Jesse Boone**, **Eli Coffey** and **George Dowell**.

On October 23, 1782, **Joel Coffey** received a land grant for 200 acres on Beaver Creek, Wilkes County, North Carolina.

On November 9, 1784, there was a deed made between **Joel Coffey** and **James Ferguson** of 1100 for 200 acres on King's Creek that was granted to **Joel Coffey** by deed from **Abraham Reece**. The witnesses were **Livingston Isbell**, **Golston Stepp**, and **Philip Davis**.

On October 27, 1788, there was a land transaction between **Joel Coffey** and **Peter Noland** 1300 for 200 acres on Beaver Creek, Wilkes County, North Carolina, that was granted to **Joel Coffey** by the state on October 23, 1782. The witnesses were **Benjamin Elledge** and **Spill Tribble**.

Many other deeds show a strong bond between **Joel Coffey** and his son **Neburazadan Coffey**.

The following entry is a transcript of **Joel Coffey's** will.

In the Name of God Amen I **Joel Coffey** of N. Carolina and County of Wilkes, tho weak in body but perfect in mind and Memory, Constitute this my last will and testament I give my Soul to God my Redeemer and my Body to be Buried in a Decent manner and after my Just Debts are paid I Dispose of my worldly goods as follows to-wit: I give my Wife **Martha** the plantation where on I now live, and all my Household furniture and two Negroes namey **Harry & Peg** and all my Stock of Horses Cattle Sheep & Hogs enduring her natural life or widowhood I also will that as much of my Land be sold by my Executor as pay my Debts. The Remainder of my Land to be Equally Divided among my Sons **Cleveland James Joel Nathan** and the Rest of my Negroes to be equally Divided among all my Children to wit **Cleveland James Joel Nathan** unto **Jane Sealy** and if my wife is at preasent with Child for if it lives to Share an Equal part with the Rest and at the Death or Marriage of my

wife for what I give to her to be Equally Divided among all my Children any preasant Estate to be improved and kept together till my youngest Child come of Age or Marry **Neburazadan Coffey** and my Son **Cleveland Coffey** Executors I Acknowledge this my last will and Testament made this 27th Day of April 1789

Reuben Coffey, son of John Coffey and Jane Graves Coffey, was born in Albemarle County, Virginia, on September 16, 1759 and married Sally Scott. He is listed in the 1790 Wilkes County, North Carolina Census: 1 free white male over 16 years old; 1 free white male under 16 years old; 4 white females, including heads of families; and no slaves.

The following is a transcript of Reuben Coffey's Pension Records, found in the Pension Office, Washington, D.C.

Reuben Coffey, Wayne County, Kentucky

Private North Carolina. Application for Revolutionary Pension.

Volunteered, June 17, 1780. 12 months and upwards, under Capt. Moses Guest. In battle of King's Mountain. Resided when entered service in Wilkes County, North Carolina.

Reuben Coffey, born in Albemarle County, Virginia, September 16, 1759.

My father moved to Amherst County, Virginia, four or five years afterwards where I lived about fifteen years. My father then moved to the State of North Carolina and settled in Wilkes County near the head of the Yadkin River where I resided several years. (I think about 14 years.) I then settled in Burke County and lived there about 22 years. I then moved to the State of Kentucky in Wayne County where I now live and have resided there a little upwards of 13 years.

Have no documentary evidence of service but can prove by Martin Durham and Lewis Coffey of being in service.

A resident of Wayne County, Kentucky, 72 years the 16th day of September last.

Volunteered under Capt. Moses Guest in Wilkes County, North Carolina, in a horse company for as long a period as the country needed my services.

On June 17, 1780, before the Battle of King's Mountain, marched under command of Capt. Moses Guest, Lt. Thos. Ferguson, Maj. Hartgrove, Maj. Joseph Winston, and Col. Ben Cleveland, with Adjutant Major Jesse Franklin.

We first marched to Ramseur's Mill in Lincoln County, North Carolina, the day after the battle there, and it was there we met General Rutherford and General Thomas Sumpter and their army. The Tories being then defeated, our regiment marched toward home, and was generally engaged in scouting after Tories. We had several small engagements with them.

The British and Tories had collected in force and marched toward Virginia as far as Burke County. We pursued them and they retreated toward King's Mountain. Our commanders were Col. Benjamin Cleveland, Col. Wm. Campbell, Col. Isaac Shelby, and Col. John Sevier.

We overtook and fought the British at King's Mountain in South Carolina and defeated them on Saturday the 7th day of October, 1780. We remained on the battle ground until Sunday the next day, and then marched with the prisoners up to one Colonel Walker's in Rutherford County, North Carolina. We then marched about three miles to the widow Bickerstaff's when a court-martial was held and condemned 90 men of the Tories. We afterwards marched through Burke, Wilkes, and toward the Moravian town. (Now Moravian Falls, N.C.)

Ensign Benj. Guest with myself and five or six others of our company were ordered back upon the frontier to quell the Tories, who caused a considerable alarm.

I was upon several small expeditions; one down to Guilford, another to Hunting creek, and another to the hollows of Yadkin.

I was sometimes stationed at Hamlin's old store in Wilkes County and at another at John Stables in Burke County, and other places, and remained in service 12 months and upwards.

Was discharged by my Captain at his own house in Wilkes County with others, in the fall of 1781, our country having no further call for our service.

Benjamin Coffey

Benjamin Coffey, son of John Coffey and Jane Graves Coffey, was born in 1747, and married Polly Hayes. He is listed in the 1790 Burke County, North Carolina, Census with 3 sons, a wife, and 1 daughter, and no slaves.

Benjamin Coffey applied for a pension based on his Revolutionary war record.
A partial statement of Benjamin Coffey's claim for Pension reads as follows:

Personally appeared before me, James Mitchell, an acting Justice of the Peace of Hawkins County, State of Tennessee, Benjamin Coffey, a resident of Hawkins County, aged 86 years.

"I entered service of the United States in Burke County, North Carolina, in year 1776, under the command of Col. Thomas Whitson, on the first of April, commanding officer being Col. Joseph McDowell. We marched to the frontier of said county in North Carolina against the Cherokee Indians that were making inroads and doing mischief on the frontier to Crider's fort on Lower creek, being employed as scout. I was discharged in September, moved from Burke to Wilkes County where I resided until first of April, 1780. I then entered the service again as a volunteer under the command of Capt. John Barton, regiment commanded by Col. Benjamin Cleveland. I was some times employed in marching to divers places where it was understood Tories were embodied, sometimes in Wilkes County, sometimes in Burke - until I received orders to march to King's Mountain against some Tories and British collected there under the command of Major Ferguson. We marched on through Lincoln County in North Carolina under the command of Col. Benjamin Hearne and Col. Benjamin Cleveland until we were joined by the forces of Col. Campbell, Col. Shelby, Col. Sevier, and Col. Williams.

"There an action took place and Ferguson was killed and his men defeated. I was not in the battle in consequence of losing my horse the night before and having to join the footmen under Col. Benj. Hearne and the foot did not come up until the battle was over; on the American side Col. Williams was killed.

"I was then sent to guard the prisoners at Moravian town in North Carolina during which march I was attacked with a pain in my ankles and was furloughed home the first of November. I never was out any more.

George Hays lived near me in North Carolina and now lives near me in Tennessee."

Elizabeth (Betty) Coffey, daughter of John Coffey and Jane Graves Coffey, married Thomas Fields.

Winnefred Coffey, daughter of John Coffey and Jane Graves Coffey, married Nicholas Moran.

Martha Coffey

Martha Coffey, daughter of John Coffey and Jane Graves Coffey, died at home on Blue Run, Orange County, Virginia, at a good old age. She married John Cleveland, who was born about 1695, and who also died on their estate on Blue Run. John had moved up the river from his home on Blue Run in Prince William County, Virginia (See Appendix).

John Cleveland and his father, Alexander Cleveland, Jr., were early settlers in Prince William County. It is very probable that John was born and reared there. He and his parents moved prior to 1734, to Orange County and located on Blue Run, where they lived until their deaths. Deed records of Orange County indicate that the Clevelands owned much land. The earliest of these records is dated 1734. About 1778, John Cleveland left a will in which he mentions nine children and two grandchildren. In 1779, a short appraisement was made of John's estate.

The children of Martha Coffey Cleveland and John Cleveland are:

- I. John Cleveland, born Virginia, 1730; died about 1821; married Mollie McHan, died before 1809. John and his brother Larkin went about 1772, from Virginia through North Carolina. They journeyed on Pack-horses and cut their road through cane and brush as they traveled. They came to Pickens District, South Carolina, and were among the first settlers. They lived in Pendleton District at Cleveland's Ferry. (Pendleton District was divided in 1828, into Anderson and Pickens. Pickens, in turn, was divided in 1866, into Pickens and Oconee Counties. The Clevelands lived primarily in Oconee County.) John was one of the first settlers of Franklin County, Georgia, about 1785, when it was still inhabited by the Indians. John's home was on the Tugaloo River (a branch of the Savannah River) and in sight of his brother Larkin's home, both residences being located on the Georgia side of the river. This is where John raised his family, who later settled at various points along the Tugaloo River. John Cleveland preached in Chauga Church, Oconee County, South Carolina, and Eastonala Church in Georgia. According to a quotation taken from THE GENEALOGY OF THE CLEVELAND AND CLEAVELAND FAMILIES, III, p. 2059. "He was good to his neighbors and the poor, kind to his many darkies, who thought their master better than any other man." (This same quotation is also found in James B. Cleveland's book on the CLEVELANDS.) John was living with his son-in-law Benjamin Harrison at the time of his (John's) death. John was a Baptist clergyman. He was a close associate of the Rev. Thomas Maxwell, Sr. in the Elbert County, Georgia area, about 1790. Maxwell was also from Orange County, Virginia. In 1819, Cleveland and Maxwell, both elderly, attended an associational meeting in Pittsylvania County, Virginia. According to another quotation found in THE GENEALOGY OF THE CLEVELAND AND CLEAVELAND FAMILIES, III, p. 2059, "Sometime when the Rev. John would preach, the wicked people would take him out of the house and beat him severely, but he would preach on, and when they let him go, he would mount a stump or log and finish his sermon."

Wright \$300.00 in cash or in some degree indemnify her for the negro wench Phillice I gave her and she had the misfortune to lose. To daughter Fanny Wright a negro woman Milley now in her possession but with the condition that should she die without issue the negro and all her increase equally divided among her brothers and sisters. To daughter Catharine Wright a negro woman Dicy. To daughter Nancy Cleveland, wife of George Cleveland, negro boy Andrew now in her possession. To son Robert Harrison Cleveland, negro boy Sampson. To daughter, Polly Cleveland negro boy Allen. To daughter Jane Cleveland negro boy Daniel. To son Oliver F. Cleveland, negro boy John. To daughter Lucinda Cleveland, negro boy Green. To daughter Elizabeth Cleveland, negro boy Jim. To son William Earl Cleveland negro boy Hugh. Negro fellows Williston and Jacob to be hired out. If their hire amounts to \$300.00 before they are sold I want that amount paid to Thomas Wright, the remainder divided among remainder of children including my daughter Patty Wright. Remainder of negroes Coop and Moll and Chester, Jack and Hannah and Peter Tom and Cato, Dick and Luse I wish to remain on the place and labor and support my wife and children. Land on Toogooloo. If wife be alive when youngest child is of age she shall have so many negroes as will be able to support her comfortable and should she find negroes troublesome she may give them up to be divided among the children. Land on Beaver Dam remain in hands of my three sons-in-law as they now have it, until younger children of age, then divided equally among my children. Larkin Wright shall have same benefit of land on which he lived on at the Beaver Dam that his brothers has for the execution of my will. Executors: Wife Nancy, son Robert H. Cleveland, son-in-law Thomas Wright, and Benjamin Harrison. Dated 31 July, 1820. (Signed) William Cleveland

- E. Fanny Cleveland, born Cleveland's Ferry; married Cleveland's Ferry to John McNeel of Carnesville, Franklin County, Georgia.
- F. Elizabeth Cleveland, born Cleveland's Ferry; died Cleveland's Ferry; married Cleveland's Ferry to Benjamin Harrison of Carnesville, Franklin County, Georgia (son of Thomas Harrison, Sr., and _____ Harrison). The following excerpts from Thomas Harrison, Sr.'s will are taken from notes made by Virginia Alexander, Colleen Morse Elliot, and Betty Willie. These indicate that Benjamin received most, if not all, of his father's estate.

"Having one unfortunate son, William, who I respect as much as any child - follows path of desperation and thought - less dealing that to me appears folly for me to give him the property for which I have labored hard - which would be squandered to the certain reduction of his helpless family - mentions William's infant children - give to son, Benjamin Harrison, in trust, plantation tools, other goods and chattels, on condition - if son, William reforms within ten years, Benjamin, at his satisfaction, make right to property - otherwise to heirs of William, by his present wife, Elizabeth, as they come of age or marry, and she to have maintenance - notes due me by John Varner, Duncan McKenzie, John Patrick _____, give to son Benjamin".

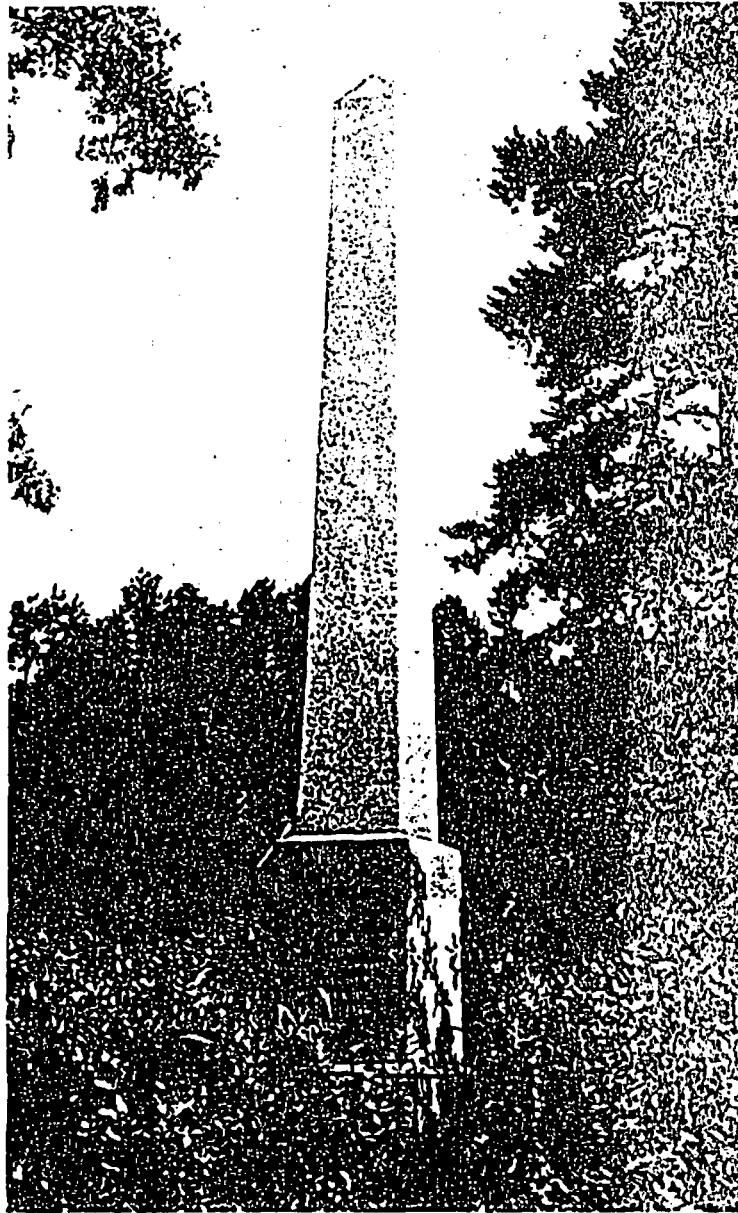

- II. Mary Cleveland, died in Wilkes County, North Carolina; married probably Orange County, Virginia, to Bernard Franklin, born May 26, 1731; died January, 1828, at age 96 (son of Laurence Franklin and Mary Payne Franklin). Almost all of Mary and Bernard's sons served in the Legislatures of North Carolina and Georgia. Bernard Franklin and his family moved from Orange County, Virginia, about 1760 (or just before 1776). They settled in Surry County, North Carolina, on Mitchell's River. Bernard's lands extended into Wilkes County, North Carolina.
 - The children of Mary Cleveland Franklin and Bernard Franklin are:
 - A. Jeremiah Franklin, born September 2, 1754; married Phibeb Franklin.
 - B. Bernard Franklin, born April 28, 1756; married Martha Cleveland.
 - C. Jesse Franklin, born March 24, 1760; died Surry County, North Carolina, September

29, 1823; married Meekey Perkins. Jesse Franklin served in the Revolutionary War and was commissioned as Major before the war ended. He served in many battles, including the one at King's Mountain with Col. Benjamin Cleveland. After the war, he was elected to various political offices for the state of North Carolina - the last being Governor for the state in 1820. Jesse Franklin and Meekey Perkins Franklin had several children.

- D. Elizabeth (Betty) Franklin, born March 10, 1762.
 - E. Abner Franklin, born April 28, 1764; married Rhoda Cleveland.
 - F. Shadrach Franklin, born April 20, 1769; died 1860; married Judith Taliaferro, born 1763; died 1848. Shadrach Franklin and Judith Taliaferro Franklin had at least nine children.
 - G. Mary Franklin, born Surry County, North Carolina, May 14, 1771; died Hawkins County, Tennessee, February 7, 1836; married Surry County, North Carolina, February 12, 1794, to Robert Nall, born Orange County, Virginia, September 24, 1767; died 1858.
 - H. Meshach Franklin, born September 17, 1773; died Surry County, North Carolina, December 18, 1839; buried at his homestead in Surry County, North Carolina; married Mildred Edwards. Meshach Franklin and Mildred Edwards Franklin had at least ten children. Meshach served the state of North Carolina in various political offices, including member of the House of Commons, State Senator, and U. S. Congressman.
 - I. Abednego Franklin, born North Carolina, May 29, 1776; died 1817; married 1800, to his cousin, Mary Graves Cleveland, died Cherokee County, Georgia, July, 1858, at age 76; buried Hightower Baptist Church Cemetery, Cherokee County, Georgia (daughter of John Cleveland and Catherine Stone Montgomery Cleveland, and granddaughter of Col. Benjamin Cleveland, who supposedly raised Mary Graves Cleveland). The inscription on Mary's tombstone is "In Memory of Mrs. Mary G. Franklin. Born March 15, 1782. Died July 31, 1858. Relict of Col. Bedney Franklin Deceased, of Morgan Co. Ga. Daughter of John & Catherine Cleveland, Grand daughter of Col. Ben Cleveland of the Revolution." Nearby is the grave of one of her children. The child's tombstone is "Erected to the memory of Dr. Bedney L. Franklin - Born February 24, 1815 - Died July 11th 1844. Aged 29 years 4 months and 17 days." Abednego Franklin and Mary Graves Franklin had several other children. Abednego Franklin was a very influential and wealthy citizen of Athens, Georgia. He was a founder of Franklin College, now known as the University of Georgia.
 - J. Benjamin Franklin, married Betsey Franklin.
 - K. Willis Franklin, died in Tennessee; never married.
 - L. Jane Franklin, moved to Tennessee; never married.
- III. Benjamin Cleveland, born Bull Run, Prince William County, Virginia, May 26, 1738; died on his plantation at the junction of Tugaloo River and Chauga Creek, Pendleton District (now Madison, Oconee County), South Carolina, October, 1806; buried on his plantation; married Orange County, Virginia, before 1764, to Miss Mary Graves of Culpepper County, Virginia. Benjamin became a Colonel in the Revolutionary War. He was the hero of the battle of King's Mountain, and was one of the most prominent members of the Cleveland family mentioned in the history of the United States. Cleveland County, North Carolina was formed in 1841, and was named in his honor. On July 28, 1887, many distinguished people attended the unveiling ceremony of a monument erected in his honor at Fort Madison, South Carolina. The following picture and excerpts are from the Centennial Edition of THE SENECA JOURNAL & TRIBUNE.



This towering monument, standing near Madison, honors the memory of one of Oconee's famous military men, Col. Benjamin Cleveland.

One of Benjamin Cleveland's good friends was the famous Daniel Boone, who described to Cleveland the bounties of Kentucky, and persuaded him to go there and look at the country. Setting out with four companions, Cleveland headed for Boone's settlement in Kentucky, but, after crossing the Cumberland Gap, the party was attacked by Cherokees, who stole a number of their horses. While he was tracking the Indians who had stolen his horses, Cleveland came upon the Tugaloo River valley for the first time. He was so impressed with it that he was later to settle there, when the Revolutionary War was over.

At the close of the War, Cleveland lost his plantation in North Carolina by a superior claim to the land, and, remembering his expedition into the Tugaloo valley, he moved his family to the junction of the Tugaloo and Chauga, where he purchased over 3000 acres of land.

The remainder of Cleveland's life was to be calm, compared with his Revolutionary days. Despite a few battles with the Cherokees on the opposite side of the Tugaloo, his military career was over, and he was to spend the rest of his life farming and serving his district, which was known as Pendleton District at that time. He served for many years with Andrew Pickens and Robert Anderson as a judge of Old Pendleton District, and he was renowned for his "promptness of decision, accuracy of judgement, and patient bearing." On a morning in 1806, he died while at breakfast.

The following entry is a W. P. A. copy of Benjamin Cleveland's last will and testament.

IN THE NAME OF GOD AMEN

I Benjamin Cleveland being weak in body but of perfect mind and memory and knowing that it is once appointed for all men to die do make this my last will and testament. And first recommend my soul to God who gave it; and my body to be decently buried and paying all lawful debts the surplusage of My property I will and bequeath in the following manner

In the first place I give to my son Absalom Cleveland after my death the tract of Land whereon I now live (except a part lying below a Branch which runs into the River below Chauga which part is to be otherwise disposed of) together with all the lands tracts or parcels of tracts of lands on either side of Tugalou River adjoining each other Together with the following Negroes Viz. Jim Lucey Venus Bess By Tom with the hold of all my live Stock Viz of Horses Cattle Hogs and Sheep and half of all my ready cash which I may have in hand after all my Just debts are paid--In the next place I Will to my grandson John Cleveland (son of absalom) one Negro Boy named prime

Item third I will to Betsy Smith daughter of Absalom Cleveland my Cupboard with all the furniture belonging to the same
Item 4 I will and Give to Benjamin Cleveland son of John Cleveland deceased after my death two negro Boys Viz Tom and Charles together with one feather bed with Common furniture

Item 5 I will and bequeath to Chapley R. Welborn one Negro Woman Charlotte with her child Ben together with one feather bed and common furniture

Item 9 I will and bequeath Bidney Franklin one Negro fellow named Jack-----I further give to my son Absalom Cleveland my set of Blacksmith tools, I further will all the residue of my property not herein before disposed to be sold and equally divided between the Children of John Cleveland Deceased, and the Children of Absalom Cleveland except one Iron gray steed Horse called Talemachey now in the possession of Jesse Coffey which studhorse I will and bequeath to the said Jesse Coffey he being my friend and relation reserving and giving the authority to my executors to dispose of two old Negroes Viz York and Dinah in what ever manner or way they shall think most advisable for the two Negroes care and convenience and that they be taken good Care of

I further will that the property in this will and testament given or bequeathed to any infant children, or Child Shall be under the direction of my executors untill the legatee becomes of full age or marries, at either of the times of full age or marring then the property to be delivered to the legatee becoming of full age or marring, and my will is further that if any of the legatees dies without issue and under age or without marring that their portion of property is to be equally divided between my Grand Children Viz the Children of my son Absalom and John Cleveland Deceased

And my will is and I do hereby appoint Absalom Cleveland, Jesse Coffey and Bidney Franklin my executors to carry unto effect this my last will and testament or a majority of them, and if there should appear a necessity in the opinion of the herein named executor that there should be one other executor, my will is that my son Absalom should appoint one and he then becomes my excutor. Hereby revoking all former will or wills signed and sealed this 10th September 1806 in presence of

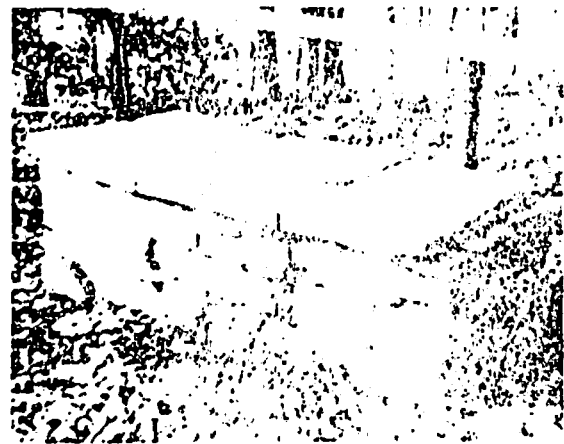

Col. Benjamin Cleveland and Mary Graves Cleveland are buried on their plantation in Oconee County, South Carolina.

And all the expenses of the same, to be paid for, out of the Money arising from the sale of the propterty, that I may hereafter direct to be sold; Also all the just debts that I may be owing to be paid like wise

Item 2nd It is my will and wish and desire that my loving wife Argin Cleveland, should retain & keep in her possession, for her own proper use, and benefit, during her natural life, or so long as she may see proper, to reside on the same, the lot of land on which I reside at this time, including the farm with all the buildings thereon; also one hundred acres adjoining the same, known as the Hufstutler lot; and _____ acres adjoining the first mentioned lot, on the North, the same being part of a let that I purchased of Robert McKinney, with such portion of Farming tools, Household and Kitchen furniture, as she may see proper to keep, for her use, also one pleasure carriage & Harness, two Claybank mares, (And the old Horse John, with as Many head of Milch Cows as she may wish, also the following named slaves to wit, Charles & his wife Rachel, I will Peggy Ginney Beck & her Son Bill) (the woman Clary to be sold) and it is my wish that that my wife keep such numbers of hogs, and sheep as she may wish for the use of the family, and such amount of provisions & Grain that may be necessary, for the use of the family, and after her death whatever amount of the above property may remain, I wish to be Sold, (with the exception of Charles Rachel & Peggy, and it is my wish that my then surviving Exr should have some provisions made for the support of the three above named slaves, during their life) and the money arising from the proceeds of the same, to be equally divided between the heirs of the body of my three daughters Mary Rush, Catharene (formerly) Johnson, but at the time of her death Catharene Hoyle

and formerly Anne Smith, but at the time of her death Anne Thorn, all of which daughters are dead, the money to be paid over to the legal Representatives of said Heirs at the death of my wife Argin Cleveland.

Item 3rd It is my will and wish that all the lots of land, that I own at my death (with the exception of the first set apart for the use of My wife Argin Cleveland, to be sold at the highest Bidder, at a twelve months credit with note and approved security, with all other stock of mules Horses Cattle Hogs, and all other perishable property, consisting of carriages wagons Carts, and such other property as has not been disposed of by the foregoing Items, and if there should be any money remaining from the proceeds of the Sale, of the foregoing property, after paying my lawful debts, I wish the same put out at the lawful Interest, until the death of my wife, and then disposed of as above set forth in the foregoing item.

Item 4th And for the purpose of carrying out the foregoing Items of this my last will and testament, I do hereby nominate Constitute & appoint, my loving wife Argin Cleveland as exrx and James C. Jarrard Executor, to act as such agreeable to the laws of the state in such cases, In testimony of which I hereunto set my hand and seal this sixth day of February in the year of our Lord one thousand eight hundred and fifth seven.

During the Revolutionary War, he became a captain and commanded a volunteer company in **Benjamin's** regiment at the Battle of King's Mountain on October 7, 1780. A soldier in his corps, **Dan White**, said that the success of this battle was due to **Robert's** bravery, for in the middle of the conflict, when the battle seemed lost, **Captain Robert Cleveland** sustained the charge until **Col. Benjamin Cleveland** could rally his fleeing soldiers and come to his aid. On April 15, 1781, **Robert** lived on Lewis Fork of the Yadkin, when he gathered some 30 good men to help rescue **Benjamin**, who had been captured by the Tories in an earlier skirmish. **Robert** spent the rest of his life on the Yadkin and was a prominent member in the community. He was one of the five **Clevelands** who served in the Electoral College and was the first one of the **Clevelands** to be chosen to that office.

Chapter 3

Thomas Coffey

Thomas Coffey, son of John Coffey and Jane Graves Coffey, was born in Essex County, Virginia, March 7, 1742, and, at age 83, died in Wilkes County (later Caldwell County) North Carolina, possibly April, 1825. He was buried first at Hull Hill Graveyard but was later removed to Harper's Chapel Burying Ground in Caldwell County, North Carolina. While Thomas was very young, his parents moved to Albemarle County, Virginia. According to available information, Thomas Coffey spend most of his youth in Albemarle County, Virginia. It was while he lived there that he, at age 18, enlisted in the French and Indian War, serving until the war ended. Thomas Coffey married first Elizabeth Smith and second Sarah Fields. Sometime between 1776 and 1781, after Elizabeth's death, Thomas, his new wife, Sarah, and his six (or possible seven) children by his first marriage moved to Wilkes County, North Carolina, settling on the upper part of the Yadkin River. For the rest of his life he lived on this land that stretched for three miles up the Yadkin. The Yadkin Grove Baptist Church was built near Thomas Coffey's home. He was a prominent, active member of that church. The 1790 Wilkes County, North Carolina Census lists Thomas Coffey with 4 males over 16; 5 males under 16; 4 females; and no slaves. Thomas Coffey made his last will and testament on January 29, 1825, approximately four months from the reputed date of his death, April, 1825. The process of settling Thomas' estate began in October of that year.

In the name of God Amen I Thomas Coffey of Wilkes County and State of North Carolina being of sound mind and memory do make and ordain this my last will and testament (Viz) first I commit my spirit to God that gave it and my body to the grave, and as to my worldly property both real and personal That Shall remain after my just debts are paid I lend it unto my beloved wife Sarah Coffey for her use during her natural life or widowhood and what remains at her death or end of her widowhood to be equally divided amongst my children (Viz) my daughter Elizabeth Allen my son John Coffeys wife and children my son Thomas Coffey my son James Coffey my daughter Mary Coffey my son Smith Coffey my daughter Patsy Dowell my son William Coffey my son Reuben Coffey my son Elijah Coffey my daughter Sally Stewart my son Lewis Coffey my son Larkin Coffey and my son McCaleb Coffey provided nevertheless that if my sd wife shall marry again that then and in that case she should have an equal share with one of my children I hereby appoint two of my sons (Viz) Smith Coffey and William Coffey executors of this my last will and testament.

This co. is commensurate with the upper valley of Catawba, enclosed on three sides by Montague hills, Blue Ridge, and Brushy mtn. The various crs. rising in these mtns. and flowing towards the interior of the county form Catawba, which flowing estrd. to the western border of Iredell, then turns abruptly to the S. and continues that course to it final issue from N.C. James Coffey

James Coffey, son of **Thomas Coffey** and **Elizabeth Smith Coffey**, was born in Virginia. On August 31, 1799, in Wilkes County, North Carolina, a marriage license was issued to **James Coffey** and **Delilah (Liley) Ferguson**. **Moses Ferguson** and **William B. Lenoir** were listed as security. **James Coffey** settled on the east side of the **Yadkin River** about three miles down river from the old homestead. He died about 1840, at the home of his son **Marvel** on **King's Creek** and was buried at **Hull Hill Graveyard**. **James Coffey** was evidently a religious man, because his name is found many times in the **Yadkin Grove Baptist Church Minutes**. At the monthly meeting in July of 1790, **Thomas Fields** (**James'** uncle by marriage) gave up the church books, and **James Coffey** was chosen by the church to be the church clerk. At the monthly meeting in April of 1791, the church appointed **James Coffey**, **Eli Coffey**, and **Jonathan Boone** as delegates to the association. At the meeting held on the

second Saturday in March of 1794, the church entered into the matter of difficulty touching principles. Brother **James Coffey** professed that he believed Jesus Christ wrought out a complete salvation for sinners and that it is offered to every person without exception. The church was inquired of to know if there was anyone else in the membership that was of the same mind, and there was none then present. The church, however, felt that it should bear with him and wait upon the Lord and search His word for instruction. The church, in addition, thought that it was not expedient for **James** to use the office of its elder until the matter was further cancelled. The minutes of Saturday before the third Sunday in January of 1832 show that **Brother James Coffey** and his wife **Delilah**, having had letters of dismissal granted heretofore, declined taking them but concluded that they would remain longer in this church.

On July 3, 1796, a marriage license was issued in **Wilkes County, North Carolina** to **William Coffey** and **Polly Coffey**. The witness was **Benjamin Coffey**. It seems that **Polly** married a distant cousin whose home was on **Buffalo Creek** about eight miles northeast of her old homeplace. They lived to a ripe old age and left a large number of descendants in **Wilkes County** and adjoining counties. They were buried at **Hull Hill Graveyard** about 1828.

In 1802, he married **Hannah Boone**, daughter of **Jesse Boone**, a brother to the legendary **Daniel Boone**. **Smith** and **Hannah** lived on the **Wilkesboro Road**, three miles east of **Lenoir**. He owned this place, where he and **Hannah** are buried, and also adjoining farms. **Smith's** brother **William Coffey** married **Hannah's** sister **Anna Boone**.

Martha Coffey

Martha (Patsy) Coffey, daughter of **Thomas Coffey** and **Sally Fields Coffey**, married **James Dowell** September 3, 1807. They settled on Mulberry Creek on the farm north of the Dowell place and eight miles west of her homeplace. A few years later, they moved to Indiana.

The following entry is a transcript of **Patsy and James'** marriage license.

We, **James Dowell** and **Reuben Coffey** of Wilkes County, and State of North Carolina, acknowledge ourselves indebted to Nath'l. Alexander, Esq., Governor, in the full sum of 500 pounds to which payment well and truly to be made. We bind ourselves, our heirs, executors, administrators, or assigns jointly, severally and firmly by these presents, sealed with our seals and dated this 3rd. of September, 1807.

The condition of the above obligation is such that whereas **James Dowell** obtained a marriage license between him and **Patsy Coffey** now if said marriage be lawful in every respect, then the above obligation to be void, or else to remain in full force, power and virtue.

Reuben Coffey (Seal)

James Dowell became a Baptist minister. The minutes of the Yadkin Grove Baptist Church state that on the last Saturday in July, 1796, the church decided to hold its next meeting at **Brother Dowell's** on Mulberry, and on the third Saturday in March, 1813, **Brother James Dowell** applied for liberty to exercise a public gift, which request was granted. On the third Saturday in January, 1824, **James Dowell** kept Sister **Northen** last month and **George Dowell** gave \$2.00 on support of Sister **Northen**. On the Saturday before the third Sunday in December, 1829, the church received **Patsy Dowell** by experience. On the Saturday before the third Sunday in September, 1832, letters of dismission were granted to **James Dowell** and his wife.

William Coffey, son of **Thomas Coffey** and **Sally Fields Coffey**, was born in Wilkes County, North Carolina, November 27, 1782, and died on May 21, 1839. On October 18, 1804, he married **Anna Boone**, who was born July 26, 1785, and died January 16, 1876. **Anna Boone** was the daughter of **Jesse Boone**, a brother to the legendary **Daniel Boone**. **Anna Boone** was a sister of **Hannah Boone**, who married **William Coffey's** brother **Smith Coffey**.

William Coffey and **Anna Boone Coffey** settled at the forks of Mulberry Creek two miles north of the old Dowell place. They are buried on their homestead on the hillside near the forks of the creek.

According to the Yadkin Grove Baptist Church Minutes, **William** and **Anna** were received by experience into that church on the third Saturday in August, 1813. On the second Saturday in October, 1813, **William Coffey** was appointed church clerk.

In **1805**, he married **Polly Dowell**, who was born **September 21, 1788**, and died in **February of 1867**. **Polly** was the sister of **James Dowell**, who married **Reuben's** sister **Patsy**.

Reuben and **Polly's** first home was on the old **Dowell** place. Later, they moved to the old **Thomas Coffey** place, and then in **1832**, they took their children and moved to **Owen County**, **Indiana**, where they lived for a short time. **Reuben** and **Polly** moved to **Monroe County**, **Indiana**, and then back to **Owen County**, where they lived until their deaths.

Reuben was a blacksmith, farmer, and mechanic. He made guns, furniture, and almost anything made of iron or wood that was used at that time. He had a patent signed by **Andrew Jackson** and made the first cast iron plow in the state of **Indiana**.

Before moving to **Indiana**, **Reuben** and **Polly** were members of the **Yadkin Grove Baptist Church**. **Reuben** joined the church in **July of 1812**, and was ordained to preach in **February of 1815**. For many years he was pastor of this and other churches in **Wilkes** and **Burke Counties**.

Reuben Coffey was a strong believer in education. He built a school house near his home, where his grandchildren got the first part of their education. In **1834**, he traveled to **Indianapolis**, **Indiana**, and became one of the founders of **Franklin College**, which was known as the **Baptist College of Indiana**.

A short time after their marriage, **McCaleb** bought a farm one mile above **Patterson**, North Carolina, where they settled, raised a large family, and resided until their deaths. They are buried at **Harper's Chapel**, **Caldwell County**, North Carolina.

The following description of **McCaleb Coffey** appears on p. 95 of **Thomas Coffey AND HIS DECENDANTS**, by **Laurence H. Coffey**.

"**McCaleb Coffey** was one of the last and best specimens of an almost extinct class of men. He was a hunter, pioneer, and backwoods farmer. Never long absent from the place where he first laid his hearthstone, commencing life with scanty means, he was able by steady work and just dealing to erect a sightly and commondious mansion, to raise a large family and equip them for active life, and to accumulate a sufficient fortune for the support of his old age."

Book II

Chapter 4

Jesse Coffey

Jesse Coffey son of Thomas Coffey and probably Elizabeth Smith Coffey (See Book II, Chapter 3). Although little is known about this Jesse Coffey (one of many Jesses), it has been established that he had died by October 12, 1807, the date that Cleveland Coffey and William Jones (See Book I, Chapter 1) applied for letters of administration of Jesse's estate. Jesse married Nancy

Some sources say that Jesse Coffey never married. According to two census records however, this claim is in error.

The 1790 Pendleton District, South Carolina Census shows Jesse Coffey with 1 free white male of 16 years and upward, including head of families; 2 free white males under 16 years of age; 4 free white females including heads of families; and no slaves. This same census also shows that Jesse Coffey is living near his cousin Benjamin Cleveland (See Book II, Chapter 2).

The 1800 Pendleton District, South Carolina Census shows Jesse Coffey with 3 males under 10 years of age; 1 male 16 to 26 years of age; a male over 45 years of age; 1 female under 10 years of age; 1 female between 10 to 16 years of age; 1 female between 16 to 26 years of age; a female over 45 years of age; and no slaves.

Exactly when Jesse Coffey moved to Wilkes County, North Carolina, is not known. Perhaps he was one of the six or seven children that traveled to that county with Thomas and Sally between 1776 and 1781. Perhaps he journeyed on ahead and sent word back to his father that good land was available. What is known is that Jesse Coffey bought 150 acres of land in that county in 1781. The following entry is a description of a claim of Jesse Coffey in Wilkes County, North Carolina.

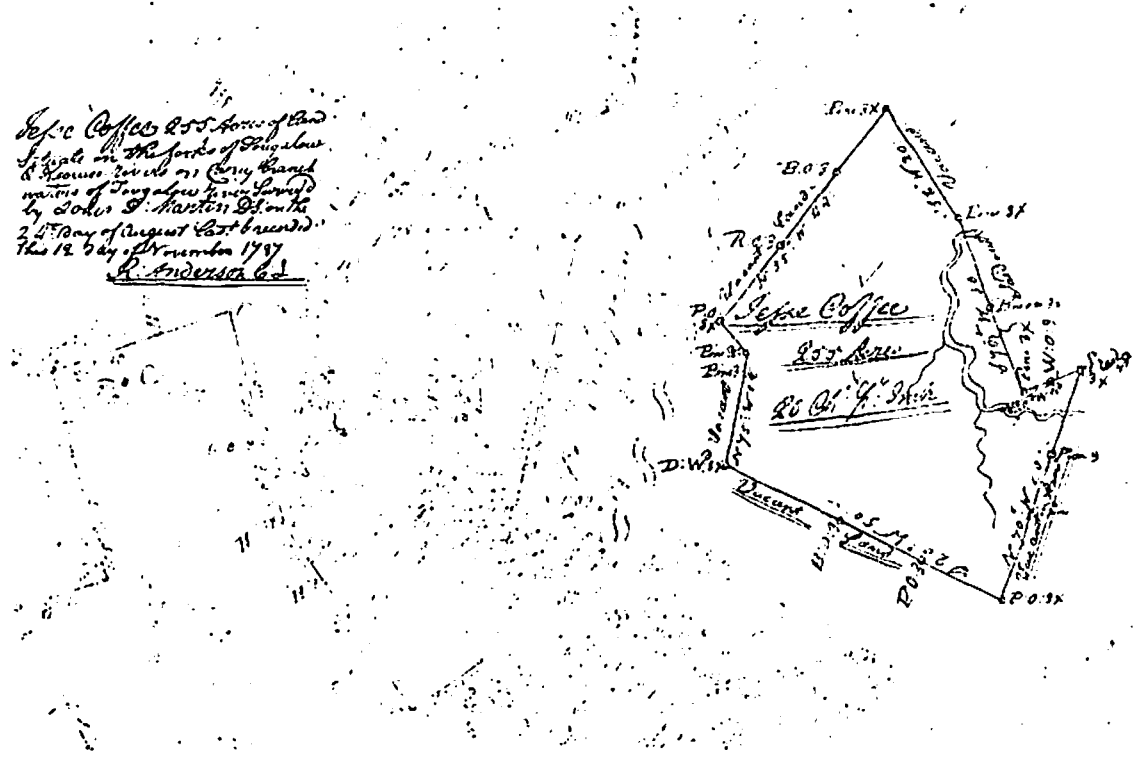

In the late 1700's, Jesse Coffey bought land in what is now Abbeville County, South Carolina. The following map is a reproduction of the original, found in Plat Book B, 1785-1788, Office of the Ordinary, Abbeville, South Carolina. This particular piece of land lay across the creek from land belonging to Ben Cobb. Perhaps Jesse bought this acreage from one of the Cobbs - perhaps from one

of his daughter-in law's (Joel's wife, Martha Cobb Coffey's) relatives.

Jesse Coffey became a resident of Pendleton District, South Carolina, at least by 1790 (per census). His reasons for moving to Pendleton may never be known, but it is highly possible that he journeyed there with his relatives, the **Cleavelands**. Jesse Coffey is involved in the following three land transactions. In the first two, Jesse is listed as living in the Pendleton District of South Carolina, and in the third, he is listed as living in Pendleton County.

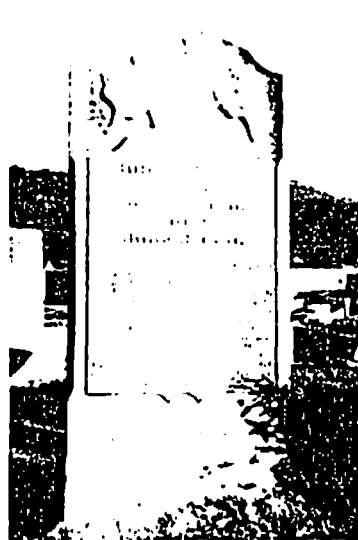

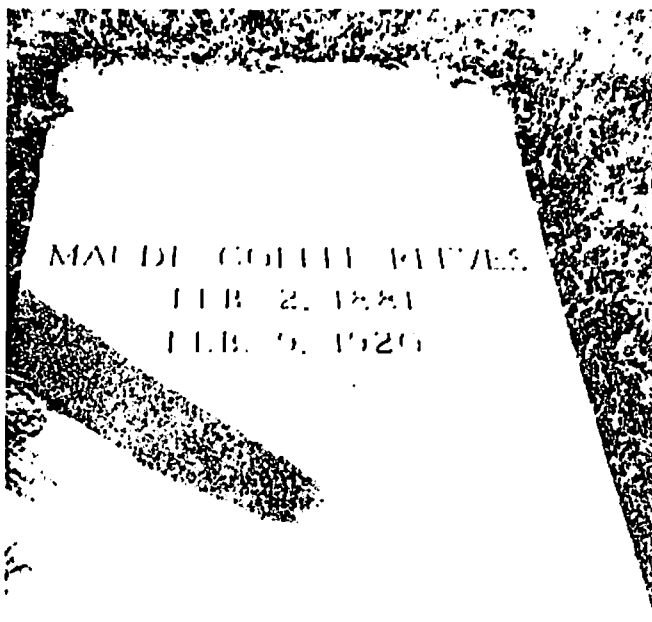

Edward Coffey

Edward Coffey, son of Jesse Coffey and Nancy _____ Coffey, was born September 29, 1793, in Pendleton District, South Carolina, although according to his tombstone, he was supposedly born in Virginia. He died May 31, 1858, in Rabun County, Georgia, and is buried with his wife, Elizabeth, at the Bleckley Cemetery, Cherchero District, Rabun County, Georgia.

Edward married Elizabeth Neville, daughter of Jesse Neville and Margaret McCarter Neville (See Book I, Chapter 1). Elizabeth was born in Pendleton District, South Carolina, on June 24, 1790, and died in Rabun County, Georgia, September 15, 1879.

Elizabeth's father's (Jesse Neville's) will was made September 13, 1838, and was proved July 25, 1842. According to that document, Jesse was a resident of Pickens District, South Carolina, and had children named Alexander, William, James, Rebecca (who married William Price), Wenneford (who married Solomon Beck), and Elizabeth (who married Edward Coffey). He gave to Edward Coffey and his wife, Elizabeth, a negro girl named Minerva. The witnesses to this will were John Adair, Enos A. Shields, and William H. England.

On December 5, 1822, at a meeting of the December Session of the Inferior Court of Rabun County, Georgia (twenty years before Jesse's will was proved), Edward Coffey and Winifred Neville Coffey obtained letters of administration on the estate of Edward's brother (John's) estate. Winifred Neville later married Solomon Beck, and was known as "Wenneford Beck" in her father's will.

Edward's name appears many times in the history of Rabun County, Georgia. He was named in public records, served in the Indian Wars, and was elected to several public offices. His influence was surely felt throughout the northern portion of Georgia.

In 1822, Edward Coffey served as the foreman of a Grand Jury. Among those that served with him were Samuel Beck, Cleveland Coffee, and Elisha Coffee.

Military records, 1829-1841, as recorded in Rabun County, Georgia, show that **Edward Coffey** served as a Captain August 26, 1830 through May 7, 1834. He is also indicated as having served as a Major from March 22, 1834 to March 2, 1836.

The following letter signed by **Edward Coffee** and others was written in 1838, during the final removal of the Cherokee Indians.

21st February 1838 Clayton Rabun County, Georgia

Governor Gilmer,

Sir we citizens of this county have adopted this method of informing your excellency. that thier is a good deal of fear and alarm existing at this time with a considerable portion of the citizens of this county, from an apprehension that thier will be depordations committed by the Indians when thier time for removal arrives from the peculiar mountainous Situation of the county adjoining as it does to a considerable extend the Lands was occupied by the Indians. And in the event of their becoming hostile we believe that they would avail themselves of the opportunity that those Large mountains there would afford them for secreting themselves and as they would nessarilly have to subsist that they would do so at the expense of our citizens property and perhaps lifes. To quiet those fears and to be prepared for any emergency, we respectfully ask of your influence with the War Department for a company of cavaldry to be stationed in the north west portion of the county
And should such a company be ordered for that purpose in a very short time it could be raised there ready for immediate Service.

Edward was Sheriff of Rabun County, Georgia, in 1825 and 1826. He served as a member of the House of Representatives for Rabun County in 1831, 1833, 1834, 1835, and 1836. He was a Convention Delegate for that county in 1833 and 1839. He also was a member of the Georgia State Senate in 1841, 1842, 1843, 1855, 1856, 1857, and until his death in 1858.

The following entry is taken from the Senate Journal of 1858. It announces the death of the **Honorable Edward Coffey**.

Mr Jarrard announced the death of the **Hon. Edward Coffee**, Senator from the county of Rabun, and offered the following resolutions, which were unannously agreed to:

Whereas the **Hon. Edward Coffee**, at the time of his death, in 1858, was a member of this Senate - as a just tribute to his distinguished usefulness as a statesman and citizen,

Be it Resolved, That in the death of **Edward Coffee**, Rabun county has lost a faithful representative, his co-laborers a sincere friend, and the world an honest man.

Resolved, That the usual badge of mourning will be worn by us during the balance of the session of the General Assembly, and that copies of these resolutions be forwarded to the family of the deceased.

Dated Wednesday, November 3, 1858.

Edward Coffey died intestate. The following papers show his son-in-law **Franklin A. Bleckley** as administrator, and are dated August 2, 1858, a couple of months after **Edward's** death.

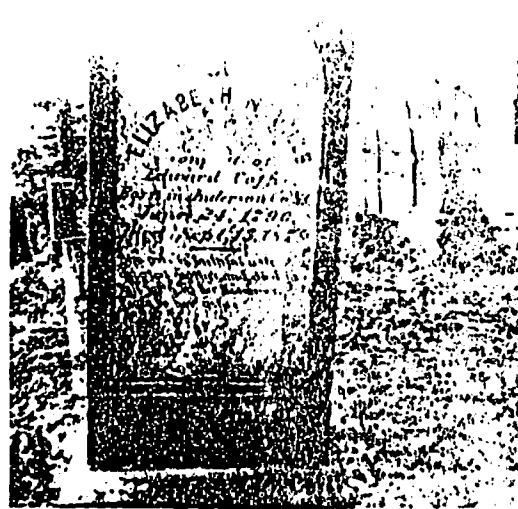
