"Children of William Edmiston, Sr., and Agnes Holmes who married ca 1750:-
Robert, Thomas, Elizabeth, John, William, Samuel, James, Andrew, Jane, Margaret.

"Robert Edmiston - 2nd Generation: son of William, Sr., and Agnes (Holmes) Edmiston; born 1753, died 1816; married Isabella Buchanan, oldest daughter of Andrew and Joannah (Hay) Buchanan. He took part in the Battle of King's Mountain (1780) with the rank of Lieutenant, was wounded in battle; lived some years in Washington County, Virginia, later moved to Cumberland, Tennessee, finally to Shelbyville, Tennessee. Children: William, Andrew J., Jane and Agnes.

"William Edmiston - 3rd Generation: son of Robert Edmiston and wife Isabella Buchanan; married Mary Edmondson, daughter of Thomas Edmiston and wife Martha Buchanan, a first cousin on the Edmiston line, a second cousin on the Buchanan line. William Edmiston was perhaps in the War of 1812 with rank of Major; gave financial aid to Joseph Buchanan, an uncle, who dedicated his book "Philosophy of Human Nature" to him.

"Andrew J. Edmiston - 3rd Generation: son of Robert Edmiston and wife Isabella Buchanan; married Marion Howard; served in the War of 1812, was in New Orleans with General Jackson, with the rank of Captain.

"Jane Edmiston - 3rd Generation: daughter of Robert Edmiston and wife Isabella Buchanan; married Mr. Wright.

"Agnes Edmiston - 3rd Generation: daughter of Robert Edmiston and wife Isabella Buchanan; married David Robinson January 3, 1797; mentioned in will of William Edmiston, Sr., then living with grandmother, Agnes. Date of marriage from Annals S. W. Virginia By Summers.

"Thomas Edmiston - 2nd Generation: son of William Edmiston, Sr., and wife Agnes Holmes; born July 25, 1759, died August 2, 1824; married Martha Buchanan April 23, 1782, who was born September 29, 1764, died September 16, 1835; a daughter of Robert Buchanan and wife Mary. Thomas Edmiston went with Robertson to Cumberland Settlement and signed the "Compact of Government." His wife, Martha Buchanan made bullets all night during an Indian siege. They lived near Nashville, Tennessee; will recorded in Davidson County, Tennessee. Children: William, Martha, Robert, Nancy, Elizabeth, Samuel, Esther, Rachael, Louise, John Black, Mary.

"William Edmiston - 3rd Generation: son of Thomas Edmiston and wife Martha Buchanan; born March 29, 1783.

"Martha Edmiston - 3rd Generation: daughter of Thomas Edmiston and wife Martha Buchanan; born March 23, 1786.

"Robert Edmiston - 3rd Generation: son of Thomas Edmiston and Martha Buchanan; born July 25, 1788.

"Nancy Edmiston - 3rd Generation: daughter of Thomas Edmiston and wife, Martha Buchanan; born April 23, 1791.

"Elizabeth Edmiston - 3rd Generation: daughter of Thomas Edmiston and wife Martha Buchanan; born April 8, 1794.

"Samuel Edmiston - 3rd Generation: son of Thomas Edmiston and wife Martha Buchanan; born June 25, 1796.

"Esther Edmiston - 3rd Generation: daughter of Thomas Edmiston and wife Martha Buchanan; born September 3, 1802.

"Rachael Edmiston - 3rd Generation: daughter of Thomas Edmiston and wife Martha Buchanan; born November 24, 1804.

Chapter XIII..abstract: Edmondstone, Edmiston and Edmondson

"Edmondstone, Edmiston, and Edmondson are the different forms of spelling of the name in different localities and generations. Edmondstone, Scotland, Ireland, Prince George County, Maryland, Edmiston in Augusta County, Virginia, and now Edmondson generally.

"The Edmondstones were of the Scottish nobility and their castle was Duntreath, Stirlingshire, Scotland. They fought on many Scotch battle fields and held positions of trust and honor under various Scottish kings. They were staunch covenanters and resisted the establishment of the episcopacy. The third lord of Duntreath fell at Flodden Field (1513), in battle. In 1600 they moved to the estate Red Hall, Ballycarry, Ireland, because of political involvements and part loss of their estate in Scotland. They were among the defenders near Londonderry in 1689 against the cause of King James II. (Battle of the Boyne, 1690.)

"The Red Hall Edmondstones were the only known family at the time of the great immigration to America where they settled in Maryland and Virginia. In Ireland, they were surrounded by Scotch kinsmen---Campbells, de Lises (Lyles), Kennedys, Adairs, McGregors, and Buchanans, who had immigrated also."

"There were two families in Maryland in the early settlements---John and brother William in 1660, Talbot County and Col. Archibald Edmondstone in Prince George County in 1680. The connection between them is not known."

"There were a number of Edmistons in Augusta County, Virginia, in the early seventeen hundrede; and among them three or four by the name of William. The names of their wives help to identify them.

"Major William Edmiston, later colonel, who commanded a regiment at King's Mountain, married first, Margaret Montgomery and had seven children:
(Another source states "Major William Edmundson, born ca 1734 Cecil County, Maryland (renamed Washington County, Virginia in 1765), married ca 1760 #1, Margaret (Nancy) Montgomery, a "cousin", their children: (named eight rather than seven):

"Louise Edmiston - 3rd Generation: daughter of Thomas Edmiston and wife Martha Buchanan; born August 3, 1807.

"John Black Edmiston - 3rd Generation: son of Thomas Edmiston and wife Martha Buchanan; born March 3, 1809.

"Mary Edmiston - 3rd Generation: daughter of Thomas Edmiston and wife Martha Buchanan; born _____, married her cousin Major William Edmondson, son of Robert Edmiston and wife Isabella Buchanan.

"Elizabeth Edmondson - 2nd Generation: daughter of William Edmiston, Sr., and wife Agnes Holmes; married Matthew Buchanan ca 1780; lived at what was known as the old Buchanan home place on South Fork Holston River, Liberty Hall neighborhood, Washington County, Virginia. Children: Andrew, Samuel, Nancy, William, Joannah, Janett, Isabella, Martha, Margaret, Mary... (See Matthew Buchanan Family).

"John Edmondson - 2nd Generation: son of William Edmiston, Sr., and wife, Agnes Holmes, born ca 1765, died ca 1845; married Mary Buchanan ca 1790, who was the daughter of Andrew Buchanan and wife Joannah Hay; served in County Militia with Rank of Major; inventory personal property Will Book IV, Page 175, Washington County, Virginia. Probably buried Old Moore Cemetery. Children: Joannah, William, Andrew, Samuel, Nancy, Betsy, Martha (Patsy), Polly, Selina, Jane, Margaret.

"Joannah Edmondson - 3rd Generation: daughter of John Edmiston (Edmondson) and wife Mary Buchanan; born April 28, 1791, died June 3, 1845; married Andrew Kelly March 22, 1810, son of John Kelly and wife Jean Kirkham. Joannah Edmondson was the oldest child of parents; her grave the first in Kelly's Chapel Cemetery, Washington County, Virginia. Children: James Edmondson, John, Andrew Buchanan, William, Louisa, Jane. (See Andrew Kelly Family.)

"William Edmondson-3rd Generation: son of John Edmondson (Edmiston) and wife Mary Buchanan; born 1793; married Myra Coffee; moved to Warren Co., Tennessee.

"Andrew Edmondson - 3rd Generation: son of John & Mary (Buchanan) Edmiston; born 1794; married Betsy Steele Edmondson, dau. of John and Mattie (Moore) Edmondson. He was known as "Broadt Andy", bought part of father's plantation from brothers & sisters.

"Martha Edmondson - 4th Generation: daughter of Andrew (Broady Andy) Edmondson and wife Betsy Steele Edmondson; married James Dolusk.

"Elizabeth Ann Edmondson - 4th Generation: daughter of Andrew (Broady Andy) Edmondson and wife Betsy Steele Edmondson; married James Crow. Children: Martha Jane, Elizabeth, Walter.

"Martha Jane Crow - 5th Generation: daughter of Elizabeth Ann Edmondson and husband James Crow; married Dr. W. H. Price, a minister Methodist Episcopal Church South; lived in Glade Spring, Virginia. Children: John W., Annie, Susie, William H.

"Elizabeth Crow - 5th Generation: daughter of Elizabeth Ann Edmondson and husband James Crow; married William Pruner; lived in Friendship, Virginia; Children: Victoria, Dora, Walter.

"Walter Crow - 5th Generation: son of Elizabeth Ann Edmondson and husband James Crow; married first, Flora Thompson; second, Mary Lyons; studied medicine, settled in Atlanta, Georgia, where he practices medicine.

"Samuel Edmiston - 3rd Generation: son of John Edmiston and wife Mary Buchanan; born 1796; married Ann Graham.

"Nancy Edmiston - 3rd Generation: daughter of John Edmiston and wife Mary Buchanan, born 1798, married Samuel Graham.

"Betsy Edmondson - 3rd Generation: daughter of John Edmiston and wife Mary Buchanan; born 1800; married Thomas Todd; moved to Indiana.

"Martha (Patsy) Edmiston - 3rd Generation: daughter of John Edmiston and wife Mary Buchanan; born 1802; married Andrew Edmondson; son of John Edmondson and wife Mattie Moore; bought part of plantation owned by John Edmiston and wife Mary Buchanan; (Children of Andrew & Betsy Steele (Edmondson) Edmondson; Martha & Elizabeth Ann.)

Lived in Liberty Hall community; she died early and he married #2, Rose Anne Buchanan. Children: Mary Betsy.

"Mary Edmondson - 4th Generation: daughter of Martha (Patsy) Edmondson and husband Andrew Edmondson; married James Keys.

"Betsy Edmondson - 4th Generation: daughter of Martha (Patsy) Edmondson and husband Andrew Edmondson; married John Blanckenbecker.

"Polly Edmiston - 3rd Generation: daughter of John Edmiston and wife Mary Buchanan; born 1804; married Hardy Riggs; moved to Warren County, Tennessee.

"Selina Edmiston - 3rd Generation: daughter of John Edmiston and wife Mary Buchanan; born 1807; married John Surber; moved to Madison County, Tennessee.

"Jane Edmondson - 3rd Generation: dau. of John Edmiston and Mary Buchanan; married John Rose; moved to Warren County, Tennessee.

"Margaret Edmondson - 3rd Generation: daughter of John Edmiston and wife Mary Buchanan; born 1814, died at home of James E. Kelly, a nephew, Washington County, Virginia.

Chapter XV: Some Edmondson Papers:

Will of William Edmiston, Sr.:-

"In the name of God Amen I William Edmiston of Washington County and State of Virginia, being weak in body but of sound mind, thanks be to God; but calling to mind the mortality of my body and that it is appointed unto all men to die, do make and ordain this as following my last will and testament...-Viz first--I do allow my executors to collect all my just debts and pay all debts justly due me. I do likewise give and bequeath to my beloved wife, Agnes Edmiston, one Sorrel Mare, likewise one third of all my cattle in Washington County and sheep and hogs and household furniture, and one fourth of all my books, the second volume of Travel works excepted also the free and unimproved use of all the improvements upon my plantation during her life; also all my farming utensils to be left upon the plantation for the use of my wife and my sons James and Samuel also to my son. William one bond of fifty pounds on James Curtis due the first of Nov., 1789; also to my son John one bond of fifty pounds on said (Curtis due 1791) one bay horse 4 years old and my stallion colt to be equally divided between him and my son James; also to my sons James and Samuel my plantation at my wife's death to be equally divided between them and provided either of them should die before my wife the other is to heir the land upon paying ten pounds to my son John; also to my son James one Brown horse 4 years old and my son Samuel one Black mare; also the remaining two parts of my personal property to be equally divided betwixt my sons James and Samuel and my daughter Margaret; also my daughter Margaret one black colt, 1 year old; also my sons James and Samuel are each of them to pay ten pounds to purchase a horse and saddle and school my son Robert's daughter Agnes if she liveth with her grandmother till she is of age. I do likewise bequeath to my son Thomas the 2nd volume of Travel works and the remaining three parts of my books to be divided between my sons John, James and Samuel; also my cattle upon Cumberland after my son Robert has satisfied himself for his trouble in taking care of them, to be equally divided between my sons John and James, except one cow to my son William.

"I do likewise appoint William Edmiston, Esq. and Mathew Buchanan, and my son John Edmiston my whole and sole executors of this my last will and testament in witness whereof I hereunto set my hand and seal this 25th day of December, 1788.

Sale of Property By Heirs of John Edmiston:-

"Joannah Edmiston Kelly, oldest child of John Edmiston and wife Mary Buchanan; and Martha Edmiston, another daughter, sold to their brother Andrew (Broady) Edmiston their share in their father's estate, which was an eleventh part for each of a tract of land on the north side of the South Fork of the Holston, containing two hundred and four acres on the 1 of March, 1825, for the sum of one hundred and thirty dollars for each.

"Later William Edmiston, Jane Edmiston Rose and Polly Edmiston Riggs of Warren County, Tennessee, sold their shares of their father's (John Edmiston) estate January 8, 1833 to Andrew Edmiston (Son of John Edmiston and Mattie Moore) who married their sister Martha (Patsy) Edmiston first; for the sum of one hundred dollars each.

"This land adjoined the land of Samuel Hawthorn, William Moore, Francis Preston, and James Hand, near Liberty Hall, Washington County, Virginia.

COLLECTION OF PAPERS RELATING TO MEMBERS OF THE EDMONDSON FAMILY

"The two Robert Edmondsons---of whom the elder was killed and the younger wounded, at the Battle of King's Mountain---were of Irish descent, and near kinsmen. Both were in the battle of the Long Island Flats of Holston (River), July 20, 1776, when some of the men retreated---young Robert among them. The elder Edmondson chided the younger for having used profane language during the engagement for which he was bound to report to his father (William Edmondson, Sr.). The young man retorted: "You too did the very same thing when the men were in flight." This accusation shocked the good man, who was a strong Presbyterian and said this charge would be an additional matter to report to the young man's father; whereupon a bystander mildly said, "It is true, I heard you."

"The younger Edmondson a Lieutenant of Beattie's Company. He subsequently settled at the Irish Station near Haysboro near Nashville, Tennessee. He was wounded in 1787 at Noely's Bend. He died in 1816 at the age of 63. Captain Andrew J. Edmondson under Andrew Jackson was his son.

"The elder Robert Edmondson was a brother of Colonel William Edmondson; the younger Robert Edmondson was a son of William Edmondson, Sr. "They were kinsmen," says Draper.

Captain Andrew Edmondson to Governor David Campbell

Washington County, Virginia:

Jan. 13, 1846

"Dear Sir:

In compliance with your request I undertake to answer your letter as my recollection now serves me but the great length of time that has elapsed since these things occurred much will necessarily be forgotten.

"My father was born in Cecil County, Maryland, in the year 1734. I know very little of his ancestry only that they were from Ireland, whilst my father was small my grandfather removed to Rockbridge, Virginia, where he lived, the county was new and thinly settled (Rockbridge county was formed in 1778 from parent counties of Augusta and Botetourt counties) & he only obtained a common English education, he married in that county and removed to the west and settled on New River which is now in Grayson County & lived some time there, sometime afterwards removed to Washington County, Virginia, where he lived until his death which took place on 30th of July, 1822---as to his services in the French and Indian War I can say little only that in examining his papers I found his commission for the Lieutenancy under King George the third and that he obtained his lands in Washington County for his services in the French & Indian War. If you will apply to Colonel George W. Hopkins our representative in Con-

gress he can tell you where my father's papers are as he has all that relates to his services both in the French and Indian and the Revolutionary Wars; I cannot say who commanded the expedition or whether my father was engaged in any battle or not during the French and Indian War; as to the Indian War in 1776 I know nothing as regards his services. When the Cherokee War broke out the families of his neighborhood went into forts. My father was very little of his time in any fort as he was generally out on some expedition or other and I believe he took part in most of the skirmishes that took place in Southwest Virginia and East Tennessee as to who commanded the middle fork of the Holston I am not able to say but judge that no one in particular as I think the men from the different forts were together and fought the Indians without any preconceived plan. I cannot say certainly whether my father was with Colonel William Christian or not but believe he was with Colonel Evan Shelby in 1779 on the Tennessee as I have heard him speak of that expedition I think he was in no battle with the British beside that of the Battle of King's Mountain and deem it not necessary to say anything on that subject as General Campbell and Judge Estell are both very familiar with the circumstances or particulars of that battle and of course have said all on that subject you desire, as to the civic offices he filled they were but few-- he was Presiding Magistrate in the county for many years and was high Sheriff -- as to his personal appearance and traits of character...he was 6 feet two inches high, with a large chest not inclined to be fleshy and weighed about 240 pounds---very firm and determined in his purpose and I think charitable to a fault. If you would write Colonel William Snodgrass I think he would give you more information about my father and his brothers than any other person living...he was a revolutionary soldier and my father and him was intimate and was together in many campaigns, he lives near Blountville, Tennessee, Sullivan County, I am, sir, Yours with great respect,
Andrew Edmondson.

"Colonel Robert B. Edmondson of Glade Springs, Virginia, was a nephew of Captain Andrew Edmondson, above, a grandson of Colonel William Edmondson, a son of Thomas Edmondson, who married Margaret Buchanan, a daughter of Robert Buchanan and wife Jane Beattie. Jane Beattie married Matthew Ryburn after the death of her first husband, Robert Buchanan." (Note by E. K. A.)

From "Early Maryland 1633-1634 --Original Narratives of Early American History.....pages 392-401...

"Descended from Thomas Edmondson who married Martha Campbell. They located in Pennsylvania ca 1690 and the Montgomerys, Buchanans and Kennedys were in the colony. They established the Abingdon Church (Presbyterian) in 1695. Thomas Edmondson removed to Cecil County, Maryland, where son, William Edmondson, was born in 1734. William had brothers named Thomas, Andrew and Robert."

Another source states: "Major (later Colonel) William Edmiston (Edmondson) born ca 1734, Cecil County, Maryland, married #1, Margaret (Nancy) Montgomery with 8 children; married #2, Mary Kennedy (called Elizabeth by others) and their 7 children; was the son of John and Margaret () Edmondson who was born ca 1699, a son of William Edmondson and Sarah Amelia Sharpe married ca 1694, who was the son of John Edmondson, the Large Merchant, of Talbot County, Maryland, whose wife Sarah () Edmondson, was left a widow in 1698.....William Edmondson, who married Sarah Amelia Sharpe (a relative of Governor Sharpe), had another son, brother of John, called William Edmondson (born ca 1694) who married Agnes Holmes. So the intricate relationship unwinds to show this lineage may be proven to be that of John Edmondson, the Large Merchant of Talbot County, a noteworthy Quaker, and by many said to be a kinsman of the Irish Quaker Preacher William Edmondson born 4 October, 1627 baptized in Saint Andrews Church in Crosby Garrett Parish, Little Musgrave, Westmoreland shire England; died in Ireland in 1712, buried in Tineal, Ireland Quakers' Burying Ground, possibly through one of his brother's lines.

PETERSBURG Aug 17th 1862

Dear Father and Mother

I take my seat this morning to tell you the sad and awful news.

James F Coffey is dead and berried, he was taken sick I dont think he has been very well for some time but he didnt complain any until Wednesday morning he got up in the morning complaining of his throat being sore he went to the doctor that morning and was excused from duty his throat commensed swelling and next morning he was sent to the hospital about 10 or 11 oclock it was Thursday when he was sent to the hoospital. On Friday evning Henry went up to see him he was still getting worse but was able to go about Then he gave Henry his money that day and told Henry he wanted Henry or myself to come back next day So I went up early next morning and was very mutch suprised to find him dead I went in the room where he was laid out and looked at him he looked very natureal I left then and came back to camp to see if there was any chance of sending him home the Captain wrote out a furlough for some of us to come with him he took the furlough to the General he would not sign it So the prospect of getting him home was a failure As soon as I came from Petersburg we sent Harrison Coffey to Petersburg to try to get a metallic coffin to put him in which he would of kept sound for years and could of been took home at any time We sent \$100.00 to pay for the coffin but there was none to be found so Harrison returned then we come to the conclusion that there was no chance to get him home so we come to the conclusion to let him be buried in a government coffin which was dressed and painted he was buried accordin to the military dissplin Henry Harrison William George Morgan George Powell John Weaver Joshua Curtis Simeon Philyaw George Sherill went to the burrying I didnt feel able to go an I was just getting over the mumphs and had just walked to Petersburg and back he died at 11 oclock Friday night the nurse saw he died in his right mind and without a struggle the nurse said that he died the easiest of any person he ever saw he got so he could not talk () minutes befor he died without saying anything about dying the whole time of his sickness We have gotten his clothes in our tent I wish they were at home Henry has got what money he had he had \$66.85 which we will send home the first safe chance I would like for father to come and see us if he has the chance and get his things He was buried 1½ miles of Petersburg Henry said that it is the largest grave yard he ever saw The boys said that James looked the most natural of any corps they ever saw Poor fellow I hope he is in a better world than this where there is no Battles to be fought and where there is no more sickness he has been a very sivel boy since he came to the army

He seemed to be liked by all who knew him he has never made any fuss or quarrel since he came into the army James has had his testament or guard daily and with delight apparently and died with it in his pocket when we would leave camp to go out on any duty he would carry his book in his pocket This is the first letter that I ever have written with my eyes full with tears I have never before had any thing to hurt me so but it is a debt which we all have to pay I would have written yesterday evening but you will get the letter as soon as it had wrote yesterday. When he gave Henry his money he told him that he was afraid somebody would steal it I regret very much that we was not with him when he died Father Mother do not think hard of us for anything for which we have done for (W)

the best we could do I suppose you are very well aware of what tight rules we are under and cannot do as we would wish to do We would like very well to see you all but the only chance for you to come see us I wrote to you on Friday but I suppose you will get this letter nearly as soon as you will get this write to me on the receipt of this letter so I may know that you have got this letter So no more at present

P S I received a letter from Charlie Friday he was well we are both as well as could be expected

James told Henry on Friday evening that his nurse was very good to him Father please come and see us and get James things if you can possible spare the time Injure yourself Read this letter to all his relatives and friends Money could not of stoped me from sending him home if I could of had the opportunity he was buried in his gray pants which he brought from home and white drawers and the worsted shirt which he brought from home and socks Henry got a white Hankerchief and tied round his jaws he was wreped in a blanket also

(This letter was recently found in an old Bible belonging to Frances Caroline (1845-1922) and David J. Farthing (1847-1918). She was the daughter of McCalab Coffey (1803-1881)

1850 January the 27th - 4th Brother W^m Coffey rose up and laid in an alegation against Brother James Gilbert Something concerning a bedtick. which was laid over till next meeting.

1850 February the 23rd - 2nd read the minute of our last meeting and the alegation laid in at our last meeting against Brother James Gilbert by Bro William Coffey was laid over till next meeting.

1850 March the 23rd - 2nd the Alegation laid in at the January by bro. W^m Coffey against Brother James Gilbert was laid over till next meeting.

1850 April the 27th - 1st inquired for fellowship all appears in peace but the old aggrieveance between Brother William Coffey and his wife Sister Sally Coffey. against Brother James Gilbert - 2nd read the Minute of our last meeting and the minute of our February meeting also -
3rd took up the agrieveance between Brother W^m Coffey and (his wife) Sister Sally Coffey against Brother James Gilbert concerning a bed tick and after a long examination of each party each party with the Whole Church agreed to take the Voice of the Church Which they thought was right. and both parties to be agreed to the act of the Church and be satisfied and say no more about the subject. the Church give their voice in favor of Brother and Sister Coffey.

1852 September the 25 day - 2 tuck up the case beteen sister Sally Coffey and Brouther James Gilbert and the moderator spok and sed Brouther James Gilbert would have to Ecknowege to sister Sally Coffey that he had dun rounq ur els Be Ecommunicated moved and second that the voic (?) of the Church be taken wether they shood turne him out ur no and the majority of the church sed turn him out.

Jesse Moore sen^r Jesse Boone W^m Penly Elijah Chambers Jesse Moore jun^r & Daniel Moore.

1806 May 10th - The Committee met according to appointment only one (?) they & the Church seeted. and then the Committee went out upon the matter that they where appointed last meeting. to try to settle between bro^r Majors & bro^r Gilbirt and they tried to settle the matter and found it a mesterious and delicate matter. and then concluded to leave it to the best helps from other churchs to wit. Yadkin Church. New River Church. & Linvil River Church to meet at our mounthly meeting on the fourth Saterdag in June next.

1806 June the fourth Saterdag & 28 day - The Church met. and chose bro^r Ambros Carlton for moderator and bro^r James McCalab for Clark for this day & received agreeable to there requist. six brethren. from the Church at linvil Ambros Carlton Timothy Siske. from the Church at the head of the Yadkin. Eli Coffey Marshal Durham. from the chuch at the three forks of New river Richard Green Henry Earnest (?) and with them & some other brethren who were present She proceeded to investigate the mattter of dealings which was taken up in fabruary last between John Majors & James Gilbirt. and after hearing the Charge & Defence and the witnesses for & against the same the Church appointed the above named Brethren except Armbras Carlton Eli Coffey Marshal Durham and Bartlet Henson. a committee to deside on the same and make report. The Committee made there report which was not concured wlt^o. the church then proceeded to decide thereon. and then adjourned till eight o'clock in the evening. - THE RECORDING

THE EDMONDSON (EDMISTON) FAMILY AND LOCATION

(15) Anne Kennedy Edmondson born 9 April, 1798. (As copied from the Bible of Major William Edmondson.) (This abstract does not give the dates or this spelling.) The seven children named in this abstract were: Margaret, Esther, Robert, Henry, John, Samuel, and Thomas. He married second Elizabeth Kennedy (sic.) and had eight children whose names were: Martha, Andrew, Betty, Hettyette, General William Campbell, William, Sally, and Ann."

"Major (later Colonel) William Edmiston (Edmondson), born in Cecil County, Maryland, 1734 and died July 30, 1822, Washington County, Virginia. He mentions sons Robert, William, General William Campbell, and Andrew; son Thomas, as an executor in his will. He received large grants of land for service with the French and Indian War. Part of this land grant extended from Friendship, Virginia, to Liberty Hall, Virginia, in Washington County. He was high Sheriff and Magistrate of the county.

"Captain William Edmiston, who was killed at battle of King's Mountain (1780), married Elizabeth William, Jr., Margaret, and Martha. He had children whose names were:

"Governor David Campbell said in a letter that the two Williams were cousins.

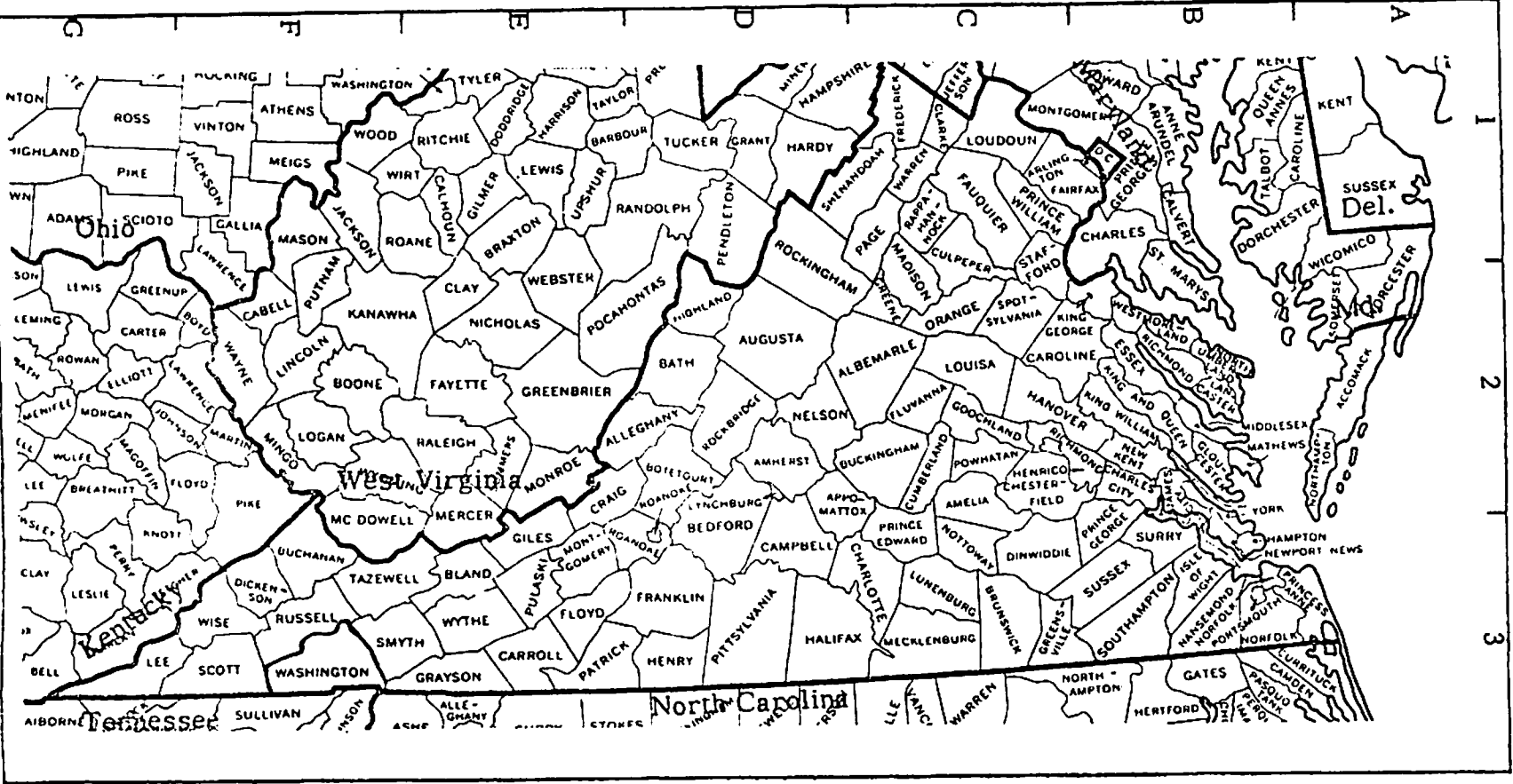
"William Edmiston, Sr., lived in the same community, bought land from Major William Edmiston---a part of the king's grant. He died in 1789 in Washington County, Virginia. He married Agnes Holmes and had ten children whose names were: Robert, Thomas, Elizabeth, John, William, Samuel, James, Andrew, Jane, Margaret. His son, Lieutenant Robert Edmiston, was wounded in the battle of King's Mountain. His son, Thomas, was also in the battle.

"There are three versions as to his ancestry. Tradition has it that he was a grandson of Archibald of Prince Georges County, Maryland. Archibald's will was recorded in Prince Georges County, Maryland, June 28, 1734. He leaves his son Thomas who was said to be father of William, certain tracts of land when he reaches seventeen years of age. Thomas was born in 1718 according to records; so it is hardly possible that he could have had a son, who had sons in the battle of King's Mountain in 1780---Lieut, Robert Edmiston was born 1753. From Tennessee comes the story---from family Bible Records---that he was the son of John Edmiston and wife Sarah Sharp of Talbot County, Maryland, and was born 1694; which would make him ninety-four years of age at his death. This John of Maryland was a prominent Quaker, which hardly fits into the picture. Lastly, there was a David Edmiston who came to Orange County, Virginia in 1740 with several sons; one William. Some authorities think that the Edmiston families of Washington county, who apparently were kin, were descendants of this David. There is no proof as yet of any of the above accounts. These three Williams along with the men by the name of John, Samuel, Robert, Andrew and Thomas signed and witnessed papers for each other, so there was close cooperation and kinship."

Chapter: XIV; William Edmiston, Sr.-Agnes Holmes

"1st Generation: was born in the early seventeen hundreds, died 1789; his will dated December 25, 1788, proven February 10, 1789, Abingdon, Virginia; married Agnes Holmes ca 1750; lived early years in Augusta County, Virginia, later years in Washington County. (In 1634 there were nine patent counties in Virginia; Auguste County was formed in 1738; Washington County was not formed until 1776-1777...so that it was formed from land that had been Augusta County and other counties were being formed in between those dates....He may never have moved. There are now 104 counties in Virginia, although West Virginia was formed from part of Virginia as a result of the Civil War....Ye Ed.)
