Elizabeth was daughter of JAMES Coffey and Jane Anderson. James Coffey was born 1733, in Essex Co., VA, to EDWARD JR. and Grace Cleveland.

Good morning Janet,

Thank you for all the good info! You're a sweetie.

You and I are thinking alike. I wrote to Bonnie yesterday that I believed Marvel was being confused with Asbury Madison. It could be that Marvel and A.M. were brothers, or close cousins.

I went through the census records last night looking for close Coffey neighbors from 1790 thru 1840. Unfortunately, some census takers thought it smart to alphabetize the people in his district. Consequently, all of the Coffee/y families end up together in some of those early census records.

My work, I fear, might have been more of an exercise in futility that in gaining any real knowledge. I'll share it with you for whatever value you can find in it. I do not want to distract you from your Boone research! However, I would appreciate it if you would let me know if you notice any factual errors.

Eli was in Wilkes Co., NC in 1790 and 1800. In 1790 it was just he and his wife. In 1800 they had one male child under 10 (born 1790-1800). Unless they were so unfortunate as to lose a number of children, I find it distracting that they had only one living child after 10 years of marriage.

In 1810 Wilkes Co. the same circumstances existed; e.g., one male child under 10; Eli was referred to as Eli, Esq. Marvel wasn't found.

In Burke Co. that year I found Smith, Elijah and Jesse. These all seem to be sons of Thomas who married 1) Eliz. Smith (Smith was her last son); 2) Sally Fields, mother of several including and Elijah and a Jesse. However, Elijah and Jesse are older than Smith in the 1810 census. There is an older male (45 and older) in the Smith household and, this could be Thomas, his father.

Down in Adair Co., KY in 1810 there was another Eli with one male child under 10 and three

females under ten. There were a lot of Coffey/e families in Adair, and just looking at some of the names; it appears they are mostly names associated with Chesley, a line for which there is precious little info. I need to review these people again.

In 1813 Marvel married Rachel Boone in Burke Co., NC; bond Benjamin Coffey, witness Daniel Moore.

By 1820 - still in Adair Co., there was an Ely [sic] in Adair along with some of the same Coffey families as in the 1810 record. By this time he was older than 45 and had eight children in the household. Marvel was in Wayne Co., KY.

It is interesting to me to note that in 1820 Burke Co. I found Smith Coffey, along with others (Archilaus, Joseph, Reuben, and William). Thomas and second wife, Sarah Fields, has sons Reuben (married Polly Dowell) and went to Owen Co., IN; and William who married Anna Boone.

In 1828 we know that Marvel sold land in McMinn Co. to Thos. Hutchinson; proved by A.M. Coffey and Thos. Boone. We know too that Jesse Boone's will was also proved by Asbury and Jonathan Allin [sic] in 1828. Asbury also married Mary Bradford in McMinn Co. that year, Jonathan Allen officiated. Perhaps in connection with the Jesse Boone will, his marriage, or some other reason, Asbury was certified in 1828 to be 21 years old and of good moral character.

In 1830 the only Eli that I can find is in Russell Co., KY. Down in McMinn Co., TN there was Asbury M. and Marvel and there was a max of 10 years difference in their ages.

In 1840 both A.M. and Eli were in McMinn Co., TN. The only other Coffey in that county was James; Marvel appears to have moved on. I cannot find him anywhere in the census that year.

We think Marvel was in Maries Co., MO by 1848.

(Marvel bought land in Maries Co MO in 12/16/1838. BC)

By 1850 Asbury Madison was in Petis Co., MO. However, in 1856 there was an Asbury Coffee [sic] in Hempstead Co., AR who was named as one of the appraisers in an estray involving John T. Coffee, L. N. Kirk, and Joseph Bennight.

Marvel is dead before 1850.

We know Asbury Madison was deceased before 1860.

In addition to this Asbury and Marvel, there are various others with the same names scattered over VA, TN, NC, KY, etc. but most came later. I do not find many with the same name as contemporaries of the two we are interested in.

Interesting to note that Thomas, Jr., brother to Smith, named a son James Asbury. James, another brother to Smith named one of his sons Marvel, born c1820.

Bottom line: I think Marvel was a native of Burke and not a son of Eli, but perhaps a son of either Smith or Elijah or Jesse. If I had to bet money on which, I'd choose Smith. Problem with Smith tho is that most agree that he didn't marry until about 1802 and Marvel was born c1790, making him a better candidate as son of Thomas and second wife, Sarah Fields. There is a gap between Elijah and Sarah, Thomas/Sally's fifth child, of nearly five years. Marvel would fit there nicely.

And, it's Marvel who I am really interested in. Who the heck was his father? And, was he Asbury (Asberry, etc) Marvel or just Marvel?!

There are so many books and genealogies available that position the children of Jesse and Sarah McMahan Boone either a parental generation head or behind where they really should be.

An example is the King version of the History of Maries Co., MO. The author names Johnathan Boone as the father of Jesse, Israel, John, Rachel (who married Marvel Coffey), and asserts that some unknown son went to CA, prospered in the gold rush, was robbed and injured and never returned to "this county." Seems if someone could remember those details, they could recall the kid's name!

In another part of the book King says that Smith Coffey was a Boone descendant through "his mother Anna." We don't know enough about Smith's mother's ancestry, but we do know that her name wasn't Anna and that she was a Smith, not a Boone. King also wrote that Anna who married William Coffey was a daughter of Israel Boone, Daniel's brother. I think it's pretty much established that Anna was a daughter of Jesse and Sarah McMahan.

I love this stuff, but I'm way behind you and Bonnie in knowledge of the Coffeys, or anybody else for that matter!! I hope your head is OK after I send all of this!

From what I have seen from various sources, this Marvel and anybody named Asbury, are two separate people. I have seen Jesse Boone's will cause confusion. Marvel Coffey, husband of Rachel Boone is, of course, mentioned in the will. Asbury Madison Coffey (A.M. Coffey) is at the end of the will as a witness (he was the attny). I think the two men's names are confused as one, because it is assumed that the "A.M." incorrectly stands for (Asberry) Marvel, as witnessing his father-in-law's will.

I have also seen this King version of the History of Maries Co., MO, and think it has royally mixed up the families. That would be extremely easy to do with everyone named the same!!

Here is what I have:

Children of Israel Boone and Martha Farmer: (Martha's identity was recently proven and disclosed on the internet by the Boone Society, so I am safe here!)

1). Jesse b. abt.1748, PA, d. Dec. 11, 1829, Athens, McMinn Co., TN, md. Sarah McMahan (McMahon) about 1772, Rowan Co., NC. She b. 1750, to James McMahan and Susannah Hildert or Hildebrand, Rowan, d. 1830, Athens, both buried in G.I. Carroll Cem.,Athens.

2). Jonathan b. Nov. 21, 1750, Rowan Co., NC, d.see (Yadkin Church Minutes), md. Susannah Nixon abt. 1773, Rowan Co., NC. Children: Thomas, Rachel (Moss), Jesse "Jeptha", Mary A.(Craddock), Eleanor (Clarke), Jeremiah, Jemima (Setzer), John, and Joel M.

3). Elizabeth b. Nov. 28, 1752, Rowan, d. 1817,Fayette, KY, md. John Powers.

4). Sarah b. abt.1754, Rowan, d. Feb. of 1777, Boonesborough, KY, md. abt. 1770, to John McMahan, b. May 23, 1741, to James McMahan and Susannah Hildert or Hildebrand. Children: James, JESSEE (there he is!), William, John, and David. (Jessee Boone, along with Asbury Madison Coffey, signed a land deal I sent in "Coffey Confusion" for Marvel Coffey and Rachel Boone, and was in Wayne, KY, in 1830. Hot Dog!!)

Children of Jesse Boone and Sarah McMahan:

- 3). Israel b. Feb. 7, 1780, Burke, d. Oct. 13, 1829, McMinn, TN, md. Elizabeth Moore on Oct. 14, 1802, St. John's River, Burke. Elizabeth b. Sept. 23, 1787, to Daniel Moore and Rachel Stone in Rowan (later Caldwell), NC. Children: Nancy (Cansler), William Daniel b. 1809, Rachel (Moss), Allen, Elizabeth (Medaris), John, Sarah Ann (Egbert), and Israel Nelson "Jack."
- 4). Sarah b. abt. 1781, d. 1823, md. Jonathan Wilson. He b. Sept. 4, 1784, NC, to John Wilson and Mary Robertson. Children: Jesse, Rachel (Archelaus Coffey), Jane (Green), and Elizabeth (Parham).

A William Julian did live in Virginia City Co., VA at the times claimed by White. He became wealthy by transporting people from England to the colony. In 1636 he brought in 12 people and received 600 acres.

He was a Justice until Nov. 6, 1646 when the "Governor and Council released Mr. William Julian from all of his offices on account of his great age."
This Wm Julian came to VA in 1609 and by 1625 was in Elizabeth City, age 43. His will was dated Apr. 14, 1657 and died childless. His estate went to the children of his wife by her former marriage to Wm. Shipp.

From meeting notes of the county court, Shipp was a contemporary of Julian. The court convened at various homes and at least once, in Oct. 1645 they met at the home of Wm. Shipp. I didn't check all dates, but the court met twice a year and probably met more than one time at Shipp's.

It appears that Smith used Vol. 1, Cavaliers and Pioneers by Nell Marion Nugent, the "famous" book that claims John Coffey (who we know as Coffin/Scoffin) came to Virginia in what year...1626 or so? Smith cites p48 of that vol. to report that Mrs. Shipp-Julian left a will in 1649 in which she names a daughter, Mary Julian, born 1627. Smith writes that this Mary Julian married John Coffey of Ireland for which Smith apparently does not offer a source. I don't have a copy of the Nugent book.

It may be that Mrs. Shipp-Julian had a daughter named Mary Shipp who married another Julian, but the widow Shipp probably did not have a child by William Julian.

Smith claims that Nicholas Julian and Margaret Waterman were parents of William Julian and cites Boyd's Marriage Index. But, this source is not - as far as I can determine - proof that they were also William's parents. I don't have a copy of the index.

It also appears that at least 13 men by the name of William Julian arrived in Virginia between 1608 and 1626. In 1624 however, there was only one in the census of Elizabeth City County, Virginia Pioneer Twp. Smith picked one who arrived in 1609, born c1566 as "the" William Julian who sired a daughter Mary and that she married a John Coffey.

The Virginia Magazine of History & Biography, Vol. 5, p455 and the William and Mary Historical Quarterly, Vol. 11, p44 are mainly my sources.

I checked the Boone Society webpage for info on Smith but found nothing.

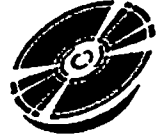
